Thank you and good morning Mr. Alamedia and to the committee, I'd like to say thank you for hearing my testimony this morning. I'd like to say I respect all the work that all of you are doing today and through the year.

I was asked to testify here late yesterday afternoon. I was invited by another concerned citizen. The only time I have had to prepare is here now this morning.

I am a member of PRO Child, Protecting Rights of Children. Our mission is to protect all children and there constitutional rights as American citizens.

My name is Giamarie Sinopoli I live at 5428 Del Rey Ave, Las Vegas, NV, 89146. I have lived here in Las Vegas for approximately five and half years.

I fled here from North Carolina. For my and my children safety, who were being threatened by my X husband to burn down the martial home while myself and my three children were sleeping inside. I did not want to be like Jessica Gonzales from Colorado. With all three of my children lying in caskets before me.

I have been a Girl Scout Council Member and a Boy Scout Leader. And a hero to the women here in the community. A mentor an advocate for women in domestic violence. A mentor and helper. Adults in the community allow me to baby sit there children entrusting there children's lives to me.

However, I am not entrusted with my own son's life by the Nevada Family District Court.  
Whom I gave life to. Whom I'd give my life for.

With that being said my x husband wanted me to terminate my son's life during pregnancy numerous times. Up to even including beating me to attempt a miscarriage.

I just like to interject. I believe all the work you're doing here is great however.

**IT SHOULD BE NOTED THAT IF JUDGES VOTED INTO THE FAMILY DISTRICT COURT, DO NOT FOLLOW THIS LAW OR THE LAWS THAT ALREADY EXIST.**

**ALL OF OUR COLLECTIVE WORK IS FUTILE.**

I believe that perhaps Judges not be allowed to use discretion or just invent there own law. But, to uphold are country, county, state and federal laws.

**And have Judges held accountable when they do not.**

To further continue, I had, had full custody of my eleven and half year old son. My x husband did not care where my son was or anything else. Until our District Attorney attempted to enforce a child support order from Nevada.

After, my x husband filed for visitation. Flew in two times from North Carolina the court took my son prisoner and sent him back to North Carolina without even an evidentiary hearing.

**Joint custody is probably BEST WHEN THERE IS NO DANGER OF SEXUAL OR PHYSICAL ASSUALT.**

**However, I never did anything wrong to my child and we can only speak for ten minutes three times a week.**

The EFFECT on my SON. When my son was taken away from me. My SON threatened to KILL himself.

And was put on XANAX to get him on the plane. I believe he thought if he said he'd kill himself. They would not force him to be a scared prisoner with a man whom molested him. 98%-94% of all allegation of molestation proven to be true.

**At age eleven and a half years old, my son knew when he was being touched inappropriately.**

My son has only been allowed to see myself and to visit with his mother only fifteen minutes in a supervised visit in a year.

My son tells me every Monday, Wednesday and Sunday.  
"I miss you. And, I want to see you."

How much can he say while being with a man whom he stated sexually and physically assaulted him. While being taped.

I've spent upward to forty-five thousand dollars plus to rescue my son in a year and a half. My son is being alienated not only from myself. But from his sisters and grandparent, aunts, uncle, cousins and extended family and step father.

My son is now living in a nightmare.  
And what has this taught my son .

That all his courage to come forward has been rewarded by removing him from, his loving, giving and caring mother.

And been giving to a man he only knew as a man who hurt him.

He can not even give praise or worship or even pray to his choosing.  
Words can not express the effects on my son.
