

ASSEMBLY BILL NO. 561—COMMITTEE ON WAYS AND MEANS

(ON BEHALF OF THE DEPARTMENT OF ADMINISTRATION)

MAY 20, 2009

Referred to Committee on Ways and Means

SUMMARY—Eliminates the Consumer Affairs Division of the Department of Business and Industry for the 2009-2011 biennium and transfers certain duties and powers of the Division. (BDR 18-1201)

AN ACT relating to reorganization of State Government; temporarily eliminating the Consumer Affairs Division of the Department of Business and Industry; temporarily eliminating the position of Commissioner of Consumer Affairs; transferring certain duties and powers of the Division and the Commissioner; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law requires the chief of each division of the Department of Business  
2 and Industry to administer the provisions of law relating to his division, subject to  
3 the administrative supervision of the Director of the Department. (NRS 232.530)  
4 **Sections 3 and 4** of this bill temporarily eliminate the Consumer Affairs Division  
5 of the Department and the position of Commissioner of Consumer Affairs for the  
6 2009-2011 biennium.  
7 Existing law provides for the regulation of garages, garagemen and body shops  
8 by the Commissioner of Consumer Affairs and for the registration or licensure of  
9 garages, garagemen and body shops with the Department of Motor Vehicles. (NRS  
10 487.530-487.570, 487.600-487.690, 597.480-597.590) **Sections 8-26** of this bill  
11 transfer authority for the regulation of garages, garagemen and body shops to the  
12 Department of Motor Vehicles and provide for the enforcement of those provisions  
13 by the Director of the Department. **Section 6** of this bill allows the Department of  
14 Motor Vehicles to impose a fine on a person who engages in certain deceptive trade  
15 practices relating to the sale or lease of a vehicle under certain circumstances.  
16 **Section 1** of this bill creates a revolving account administered by the Consumer’s



17 Advocate, to be used to pay the costs of conducting certain undercover  
18 investigations.

19 Existing law requires the Consumer Affairs Division to administer certain  
20 provisions of law governing credit service organizations. (NRS 598.701-598.787)  
21 **Sections 52-56** of this bill transfer the powers and duties of the Consumer Affairs  
22 Division relating to credit service organizations to the Division of Mortgage  
23 Lending of the Department of Business and Industry.

24 **Sections 36-47 and 49** of this bill temporarily transfer the powers and duties of  
25 the Commissioner of Consumer Affairs relating to deceptive trade practices to the  
26 Attorney General.

27 Existing law requires the Consumer Affairs Division to administer certain  
28 provisions of law governing sellers of travel, sightseeing tours, organizations for  
29 buying goods or services, and dance studios and health clubs. (NRS 598.305-  
30 598.966) **Section 51** of this bill provides that complaints concerning the charges for  
31 a sightseeing tour may be directed to the Attorney General. **Sections 57-61** of this  
32 bill temporarily authorize the Attorney General solely to enforce certain provisions  
33 relating to organizations for buying goods or services at a discount, dance studios  
34 and health clubs.

35 **Sections 63-75** of this bill authorize the Attorney General to enforce certain  
36 provisions relating to solicitation by telephone.

37 **Section 80** of this bill restores the Consumer Affairs Division, the position of  
38 the Commissioner of Consumer Affairs and the powers and duties of the Division  
39 and the Commissioner relating to deceptive trade practices, sellers of travel,  
40 sightseeing tours, organizations for buying goods or services, and dance studios and  
41 health clubs effective July 1, 2011.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 228 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3 *1. There is hereby created a revolving account for the Bureau*  
4 *of Consumer Protection in the sum of \$7,500, which must be used*  
5 *for the payment of expenses relating to conducting an undercover*  
6 *investigation of a person who is allegedly engaging in a deceptive*  
7 *trade practice or violating any provision of sections 10 to 26,*  
8 *inclusive, of this act.*

9 *2. The Consumer's Advocate shall deposit the money in the*  
10 *revolving account in a bank or credit union qualified to receive*  
11 *deposits of public money as provided by law, and the deposit must*  
12 *be secured by a depository bond satisfactory to the State Board of*  
13 *Examiners.*

14 *3. The Consumer's Advocate or his designee may:*

15 *(a) Sign all checks drawn upon the revolving account; and*

16 *(b) Make withdrawals of cash from the revolving account.*

17 *4. Payments made from the revolving account must be*  
18 *promptly reimbursed from the legislative appropriation, if any, to*  
19 *the Consumer's Advocate for the expenses relating to conducting*  
20 *an undercover investigation of a person who is allegedly engaging*

1 *in a deceptive trade practice or violating any provision of sections*  
2 *10 to 26, inclusive, of this act. The claim for reimbursement must*  
3 *be processed and paid as other claims against the State are paid.*

4 **5. The Consumer's Advocate shall:**

5 (a) *Approve any disbursement from the revolving account; and*  
6 (b) *Maintain records of any such disbursement.*

7 **Sec. 2.** NRS 228.300 is hereby amended to read as follows:

8 228.300 As used in NRS 228.300 to 228.390, inclusive, *and*  
9 *section 1 of this act*, unless the context otherwise requires, the  
10 words and terms defined in NRS 228.302 to 228.308, inclusive,  
11 have the meanings ascribed to them in those sections.

12 **Sec. 3.** NRS 232.510 is hereby amended to read as follows:

13 232.510 1. The Department of Business and Industry is  
14 hereby created.

15 2. The Department consists of a Director and the following:

36 1. Shall appoint a chief or executive director, or both of them,  
37 of each of the divisions, offices, commissions, boards, agencies or  
38 other entities of the Department, unless the authority to appoint such  
39 a chief or executive director, or both of them, is expressly vested in  
40 another person, board or commission by a specific statute. In  
41 making the appointments, the Director may obtain lists of qualified  
42 persons from professional organizations, associations or other  
43 groups recognized by the Department, if any. The ~~chief of the~~  
44 ~~Consumer Affairs Division is the Commissioner of Consumer~~  
45 ~~Affairs, the~~ chief of the Division of Financial Institutions is the



1 Commissioner of Financial Institutions, the chief of the Housing  
2 Division is the Administrator of the Housing Division, the chief of  
3 the Manufactured Housing Division is the Administrator of the  
4 Manufactured Housing Division, the chief of the Real Estate  
5 Division is the Real Estate Administrator, the chief of the Division  
6 of Insurance is the Commissioner of Insurance, the chief of the  
7 Division of Industrial Relations is the Administrator of the Division  
8 of Industrial Relations, the chief of the Office of Labor  
9 Commissioner is the Labor Commissioner, the chief of the Taxicab  
10 Authority is the Taxicab Administrator, the chief of the Nevada  
11 Transportation Authority is the Chairman of the Authority, the chief  
12 of the Division of Mortgage Lending is the Commissioner of  
13 Mortgage Lending and the chief of any other entity of the  
14 Department has the title specified by the Director, unless a different  
15 title is specified by a specific statute.

16 2. Is responsible for the administration of all provisions of law  
17 relating to the jurisdiction, duties and functions of all divisions and  
18 other entities within the Department. The Director may, if he deems  
19 it necessary to carry out his administrative responsibilities, be  
20 considered as a member of the staff of any division or other entity of  
21 the Department for the purpose of budget administration or for  
22 carrying out any duty or exercising any power necessary to fulfill  
23 the responsibilities of the Director pursuant to this subsection. This  
24 subsection does not allow the Director to preempt any authority or  
25 jurisdiction granted by statute to any division or other entity within  
26 the Department or to act or take on a function that would contravene  
27 a rule of court or a statute.

28 3. May:

29 (a) Establish uniform policies for the Department, consistent  
30 with the policies and statutory responsibilities and duties of the  
31 divisions and other entities within the Department, relating to  
32 matters concerning budgeting, accounting, planning, program  
33 development, personnel, information services, dispute resolution,  
34 travel, workplace safety, the acceptance of gifts or donations, the  
35 management of records and any other subject for which a uniform  
36 departmental policy is necessary to ensure the efficient operation of  
37 the Department.

38 (b) Provide coordination among the divisions and other entities  
39 within the Department, in a manner which does not encroach upon  
40 their statutory powers and duties, as they adopt and enforce  
41 regulations, execute agreements, purchase goods, services or  
42 equipment, prepare legislative requests and lease or use office space.

43 (c) Define the responsibilities of any person designated to carry  
44 out the duties of the Director relating to financing, industrial  
45 development or business support services.

1 4. May, within the limits of the financial resources made  
2 available to him, promote, participate in the operation of, and create  
3 or cause to be created, any nonprofit corporation, pursuant to  
4 chapter 82 of NRS, which he determines is necessary or convenient  
5 for the exercise of the powers and duties of the Department. The  
6 purposes, powers and operation of the corporation must be  
7 consistent with the purposes, powers and duties of the Department.

8 5. For any bonds which he is otherwise authorized to issue,  
9 may issue bonds the interest on which is not exempt from federal  
10 income tax or excluded from gross revenue for the purposes of  
11 federal income tax.

12 6. May, except as otherwise provided by specific statute, adopt  
13 by regulation a schedule of fees and deposits to be charged in  
14 connection with the programs administered by him pursuant to  
15 chapters 348A and 349 of NRS. Except as otherwise provided by  
16 specific statute, the amount of any such fee or deposit must not  
17 exceed 2 percent of the principal amount of the financing.

18 7. May designate any person within the Department to perform  
19 any of the duties or responsibilities, or exercise any of the authority,  
20 of the Director on his behalf.

21 8. May negotiate and execute agreements with public or private  
22 entities which are necessary to the exercise of the powers and duties  
23 of the Director or the Department.

24 9. May establish a trust account in the State Treasury for  
25 depositing and accounting for money that is held in escrow or is on  
26 deposit with the Department for the payment of any direct expenses  
27 incurred by the Director in connection with any bond programs  
28 administered by the Director. The interest and income earned on  
29 money in the trust account, less any amount deducted to pay for  
30 applicable charges, must be credited to the trust account. Any  
31 balance remaining in the account at the end of a fiscal year may be:

32 (a) Carried forward to the next fiscal year for use in covering the  
33 expense for which it was originally received; or

34 (b) Returned to any person entitled thereto in accordance with  
35 agreements or regulations of the Director relating to those bond  
36 programs.

37 **Sec. 5.** NRS 482.5434 is hereby amended to read as follows:

38 482.5434 "Body shop" has the meaning ascribed to it in ~~NRS~~  
39 ~~487.600.]~~ *section 8 of this act.*

40 **Sec. 6.** NRS 482.554 is hereby amended to read as follows:

41 482.554 1. The Department may impose an administrative  
42 fine of not more than \$10,000 against any person who engages in a  
43 deceptive trade practice. The Department shall afford to any person  
44 so fined an opportunity for a hearing pursuant to the provisions of  
45 NRS 233B.121.



1 2. For the purposes of this section, a person shall be deemed to  
2 be engaged in a "deceptive trade practice" if, in the course of his  
3 business or occupation, he:

4 (a) Enters into a contract for the sale of a vehicle on credit with  
5 a customer, exercises a valid option to cancel the vehicle sale and  
6 then, after the customer returns the vehicle with no damage other  
7 than reasonable wear and tear, the seller:

8 (1) Fails to return any down payment or other consideration  
9 in full, including, returning a vehicle accepted in trade;

10 (2) Knowingly makes a false representation to the customer  
11 that the customer must sign another contract for the sale of the  
12 vehicle on less favorable terms; or

13 (3) Fails to use the disclosure as required in subsection 3.

14 (b) Uses a contract for the sale of the vehicle or a security  
15 agreement that materially differs from the form prescribed by law.

16 (c) Engages in any deceptive trade practice, as defined in NRS  
17 598.0915 to 598.0925, inclusive, that involves the purchase and sale  
18 or lease of a motor vehicle.

19 (d) Engages in any other acts prescribed by the Department by  
20 regulation as a deceptive trade practice.

21 3. If a seller of a vehicle exercises a valid option to cancel the  
22 sale of a vehicle to a customer, the seller must provide a disclosure,  
23 and the customer must sign that disclosure, before the seller and  
24 customer may enter into a new agreement for the sale of the same  
25 vehicle on different terms, or for the sale of a different vehicle. The  
26 Department shall prescribe the form of the disclosure by regulation.

27 4. All administrative fines collected by the Department  
28 pursuant to this section must be deposited with the State Treasurer  
29 to the credit of the State Highway Fund.

30 5. ~~[Except as otherwise provided in this subsection, the]~~ *The*  
31 administrative remedy provided in this section is not exclusive and  
32 is ~~[intended to supplement existing law. The Department may not~~  
33 ~~impose a fine pursuant to this section against any person who~~  
34 ~~engages in a deceptive trade practice if a fine has previously been~~  
35 ~~imposed against that person pursuant to NRS 598.0903 to 598.0999,~~  
36 ~~inclusive, for the same act.]~~ *in addition to any other remedy*  
37 *provided by law.* The provisions of this section do not deprive a  
38 person injured by a deceptive trade practice from resorting to any  
39 other legal remedy.

40 **Sec. 7.** Chapter 487 of NRS is hereby amended by adding  
41 thereto the provisions set forth as sections 8 to 26, inclusive, of this  
42 act.

43 **Sec. 8.** *"Body shop" means any place where the body of a*  
44 *motor vehicle is painted, fixed, repaired or replaced for*  
45 *compensation.*



1     **Sec. 9.** *“Person authorizing repairs” means a person who*  
2 *uses the services of a garage. The term includes an insurance*  
3 *company, its agents or its representatives authorizing repairs to*  
4 *motor vehicles under a policy of insurance.*

5     **Sec. 10. 1.** *Each garageman shall display conspicuously in*  
6 *those areas of his place of business frequented by persons seeking*  
7 *repairs on motor vehicles a sign, not less than 22 inches by 28*  
8 *inches in size, setting forth in boldface letters the following:*

19 *3. The sign required pursuant to the provisions of subsection*  
20 *1 or 2 must include a replica of the Great Seal of the State of*  
21 *Nevada. The Seal must be 2 inches in diameter and be centered on*  
22 *the face of the sign directly above the words "STATE OF*  
23 *NEVADA."*

24 *4. Any person who violates the provisions of this section is*  
25 *guilty of a misdemeanor.*

26 **Sec. 11.** *Whenever any body shop or garageman accepts or*  
27 *assumes control of a motor vehicle for the purpose of making or*  
28 *completing any repair, the body shop or garageman shall comply*  
29 *with the provisions of sections 12 to 24, inclusive, of this act.*

30 **Sec. 12.** *1. Except as otherwise provided in section 14 of*  
31 *this act, a person requesting or authorizing the repair of a motor*  
32 *vehicle that is more than \$50 must be furnished a written estimate*  
33 *or statement signed by the person making the estimate or*  
34 *statement on behalf of the body shop or garageman indicating the*  
35 *total charge for the performance of the work necessary to*  
36 *accomplish the repair, including the charge for labor and all parts*  
37 *and accessories necessary to perform the work.*

38 *2. If the estimate is for the purpose of diagnosing a*  
39 *malfunction, the estimate must include the cost of:*

40 *(a) Diagnosis and disassembly; and*

41 *(b) Reassembly, if the person does not authorize the repair.*

42 *3. The provisions of this section do not require a body shop or*  
43 *garageman to reassemble a motor vehicle if the body shop or*  
44 *garageman determines that the reassembly of the motor vehicle*  
45 *would render the vehicle unsafe to operate.*



1     **Sec. 13.** *Except as otherwise provided in section 14 of this*  
2 *act, if it is determined that additional charges are required to*  
3 *perform the repair authorized, and those additional charges*  
4 *exceed, by 20 percent or \$100, whichever is less, the amount set*  
5 *forth in the estimate or statement required to be furnished*  
6 *pursuant to the provisions of section 12 of this act, the body shop*  
7 *or garageman shall notify the owner and insurer of the motor*  
8 *vehicle of the amount of those additional charges.*

9     **Sec. 14.** *The person authorizing the repairs may waive the*  
10 *estimate or statement required pursuant to the provisions of*  
11 *section 12 of this act or the notification required by section 13 of*  
12 *this act by executing a written waiver of that requirement or*  
13 *notification. The waiver must be executed by the person*  
14 *authorizing the repairs at the time he authorizes those repairs.*

15     **Sec. 15.** *If a body shop or garage performs repairs on a*  
16 *motor vehicle, the body shop or garage shall perform the repairs*  
17 *in accordance with any specifications of the manufacturer of the*  
18 *motor vehicle and the written estimate or statement of the cost of*  
19 *the repairs that is most recently agreed upon by the body shop or*  
20 *garage and the person authorizing the repairs.*

21     **Sec. 16.** *1. An owner and the insurer of a motor vehicle*  
22 *who have been notified of additional charges pursuant to section*  
23 *13 of this act shall:*

24     *(a) Authorize the performance of the repair at the additional*  
25 *expense; or*

26     *(b) Without delay, and upon payment of the authorized*  
27 *charges, take possession of the motor vehicle.*

28     *2. Until the election provided for in subsection 1 has been*  
29 *made, the body shop or garageman shall not undertake any repair*  
30 *which would involve such additional charges.*

31     *3. If the owner or insurer of the motor vehicle elects to take*  
32 *possession of the motor vehicle but fails to take possession within*  
33 *24 hours after the election, the body shop or garageman may*  
34 *charge for storage of the vehicle.*

35     **Sec. 17.** *1. Whenever the repair work performed on a*  
36 *motor vehicle requires the replacement of any parts or accessories,*  
37 *the body shop or garageman shall, at the request of the person*  
38 *authorizing the repairs or any person entitled to possession of the*  
39 *motor vehicle, deliver to the person all parts and accessories*  
40 *replaced as a result of the work done.*

41     *2. The provisions of subsection 1 do not apply to parts or*  
42 *accessories which must be returned to a manufacturer or*  
43 *distributor under a warranty arrangement or which are subject to*  
44 *exchange, but the customer, on request, is entitled to be shown the*  
45 *warranty parts for which a charge is made.*



1     **Sec. 18.** *The body shop or garageman shall retain copies of*  
2 *any estimate, statement or waiver required by sections 12 to 24,*  
3 *inclusive, of this act as an ordinary business record of the body*  
4 *shop or garage, for a period of not less than 1 year after the date*  
5 *the estimate, statement or waiver is signed.*

6     **Sec. 19.** *In every instance where charges are made for the*  
7 *repair of a motor vehicle by a garageman, the garageman making*  
8 *the repairs shall comply with the provisions of sections 12 to 24,*  
9 *inclusive, of this act. A garageman is not entitled to detain a motor*  
10 *vehicle by virtue of any common law or statutory lien, or otherwise*  
11 *enforce such a lien, or to sue on any contract for repairs made by*  
12 *him unless he has complied with the requirements of sections 12*  
13 *to 24, inclusive, of this act.*

14     **Sec. 20.** *A person shall be deemed to be engaged in a*
