SUMMARY—Creates statutory subcommittees of the Advisory Commission on the Administration of Justice. (BDR 14-626)

AN ACT relating to the criminal justice system; creating statutory subcommittees of the Advisory Commission on the Administration of Justice; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 **Section 2** of this bill creates in statute the Subcommittee on Juvenile Justice of
- 2 the Advisory Commission on the Administration of Justice. **Section 2** also: (1)
- 3 requires the Chairman of the Commission to appoint the members of the
- 4 Subcommittee; (2) requires the Subcommittee to study issues related to juvenile
- 5 justice and report to the Commission with recommendations to address such issues;
- 6 and (3) sets forth the salaries and per diem that members of the Subcommittee may
- 7 receive.
- 8 **Section 3** of this bill creates in statute a Subcommittee on Victims of Crime of
- 9 the Advisory Commission on the Administration of Justice. **Section 3** also: (1)
- 10 requires the Chairman of the Commission to appoint the members of the
- 11 Subcommittee; (2) requires the Subcommittee to study issues related to victims of
- 12 crime and report to the Commission with recommendations to address such issues;
- 13 and (3) sets forth the salaries and per diem that members of the Subcommittee may
- 14 receive.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 176 of NRS is hereby amended by adding
- 2 thereto the provisions set forth as sections 2 and 3 of this act.
- 3 **Sec. 2. 1. *There is hereby created the Subcommittee on***
- 4 ***Juvenile Justice of the Commission.***

1       2. *The Chairman of the Commission shall appoint the*  
2 *members of the Subcommittee and designate one of the members*  
3 *of the Subcommittee as Chairman of the Subcommittee.*

4       3. *The Subcommittee shall meet at the times and places*  
5 *specified by a call of the Chairman. A majority of the members of*  
6 *the Subcommittee constitutes a quorum, and a quorum may*  
7 *exercise any power or authority conferred on the Subcommittee.*

8       4. *The Subcommittee shall consider issues related to juvenile*  
9 *justice and shall evaluate, review and submit a report to the*  
10 *Commission with recommendations concerning such issues.*

11       5. *Any Legislators who are members of the Subcommittee are*  
12 *entitled to receive the salary provided for a majority of the*  
13 *members of the Legislature during the first 60 days of*  
14 *the preceding session for each day's attendance at a meeting of*  
15 *the Subcommittee.*

16       6. *While engaged in the business of the Subcommittee, to the*  
17 *extent of legislative appropriation, each member of the*  
18 *Subcommittee is entitled to receive the per diem allowance and*  
19 *travel expenses provided for state officers and employees*  
20 *generally.*

21       **Sec. 3.** *1. There is hereby created the Subcommittee on*  
22 *Victims of Crime of the Commission.*

23       2. *The Chairman of the Commission shall appoint the*  
24 *members of the Subcommittee and designate one of the members*  
25 *of the Subcommittee as Chairman of the Subcommittee.*

26       3. *The Subcommittee shall meet at the times and places*  
27 *specified by a call of the Chairman. A majority of the members of*  
28 *the Subcommittee constitutes a quorum, and a quorum may*  
29 *exercise any power or authority conferred on the Subcommittee.*

30       4. *The Subcommittee shall consider issues related to victims*  
31 *of crime and shall evaluate, review and submit a report to the*  
32 *Commission with recommendations concerning such issues.*

33       5. *Any Legislators who are members of the Subcommittee are*  
34 *entitled to receive the salary provided for a majority of the*  
35 *members of the Legislature during the first 60 days of*  
36 *the preceding session for each day's attendance at a meeting of*  
37 *the Subcommittee.*

38       6. *While engaged in the business of the Subcommittee, to the*  
39 *extent of legislative appropriation, each member of the*  
40 *Subcommittee is entitled to receive the per diem allowance and*  
41 *travel expenses provided for state officers and employees*  
42 *generally.*



- 1     **Sec. 4.** NRS 176.0121 is hereby amended to read as follows:  
2     176.0121 As used in NRS 176.0121 to 176.0129, inclusive,  
3     *and sections 2 and 3 of this act*, “Commission” means the Advisory  
4     Commission on the Administration of Justice.  
5     **Sec. 5.** This act becomes effective on July 1, 2009.
