The State Environmental Commission (SEC) will hold a meeting on Wednesday, May 3, 2017 at 10:00 am in Carson City. The meeting location is in the Bryan Building located at 901 South Stewart Street, 2<sup>nd</sup> Floor, Tahoe Conference Room.

#### 4) Rawhide Mining, LLC, NOAV (Notice of Alleged Violation) No. 2577 (For Possible Action)

**Recommendation:** Approve the recommended penalty of \$6,480.00 for Rawhide Mining, LLC for failure to pass a source test, in violation of Permit AP1041-2892, as specified in NOAV No. 2577, or take other action as appropriate.

**5) L. Mackedon and Sons, Inc., NOAV No. 2587 (For Possible Action)**

**Recommendation:** Approve the recommended penalty of \$4,000.00 for L. Mackedon and Sons, Inc. for failure to apply for and obtain an Air Quality Operating Permit, as specified in NOAV No. 2587, or take other action as appropriate.

**6) Tahoe Western Asphalt, LLC, NOAV No. 2601 (For Possible Action)**

**Recommendation:** Approve the recommended penalty of \$1,500.00 for Tahoe Western Asphalt, LLC for failure to comply with Visible Emissions Observation for Opacity, as specified in NOAV No. 2601, or take other action as appropriate.

**TEMPORARY REGULATORY PETITIONS**

**7) Temporary Regulatory Petition 2017-01: Bureaus of Air Quality Planning & Air Pollution Control (For Possible Action)**

**Recommendation:** Adopt Temporary Regulatory Petition T2017-01, as proposed by the Nevada Division of Environmental Protection (NDEP), or take other action as appropriate.

The NDEP proposed amendment pertains to NAC Chapter 445B. The NDEP proposes to revise the air quality public notice rule provisions by removing the requirement to provide public notice of a draft air permit, and other program actions, through publication in a newspaper. The amendment proposes to instead provide for electronic noticing (e-notice) and website access (e-access) for those actions.

**8) Temporary Regulatory Petition 2017-02: Bureaus of Air Quality Planning & Air Pollution Control (For Possible Action)**

**Recommendation:** Adopt Temporary Regulatory Petition T2017-02, as proposed by NDEP, or take other action as appropriate.

The proposed amendment pertains to NAC Chapter 445B. The NDEP proposes to provide an exemption, under specific conditions, from requirements that specific vehicles registered in Nevada that were originally equipped with pollution control devices have those devices correctly installed and in good operating condition.

This effort will align the regulations so that Nevada will be able to apply for beneficiary status in the matter of the Volkswagen 2.0L Partial Consent Decree Environmental Mitigation Trust Agreement and receive approximately \$25 million.

Over the next two years, the Volkswagen Group will address the emissions from at least 85% of the vehicles subject to the exemption.

NDEP Administrator, Greg Lovato, will brief the SEC on management changes, the State legislative session, flood response, the Anaconda Site and status of USEPA priorities and grant funding.
