*The intent of this regulation is to comply with SB460 Sec.39 and 41.5 and while remaining in compliance with NRS 391.019(3) and NRS 391B Article III(3). This regulation will require educators who only apply for an initial license or renewal of a elementary license to have completed coursework as described below. This regulation may be included in NAC 391.095 as amended by R090-19 section 4.*

**391.XXX**

- 1. Except as provided for in paragraph 2, a person who applies for an initial elementary teaching license must have completed coursework approved by the Commission in foundational literacy that include(s):*
  - a. Training and instruction in effective methods for teaching foundational literacy skills aligned with the science of reading, including, without limitation:*
    - (I) Phonological and phonemic awareness;*
    - (II) Phonics, including, without limitation, decoding and encoding;*
    - (III) Fluency;*
    - (IV) Vocabulary; and*
    - (V) Comprehension;*
  - b. Techniques for differentiating literacy instruction, to meet the needs of pupils with advanced literacy skills, as well as pupils with reading deficiencies, including, without limitation, pupils with indicators of dyslexia and pupils with disabilities;*
  - c. Implementation of effective literacy instruction using high-quality instructional materials in alignment with current research on the science of reading;*
  - d. Classroom behavior management, trauma-informed practices and other developmentally appropriate supports to ensure a conducive learning environment for literacy instruction; and*
  - e. The use of data concerning pupils, including, without limitation, literacy assessments, to make instructional decisions, including, without limitation, decisions about improving the effectiveness of classroom reading instruction and the design of reading interventions.*
- 2. A person who applies for and is granted an initial elementary license; via reciprocity as provided for in this chapter is required to have completed coursework as described in paragraph 1(a-e) upon renewal of their license.*

EXPLANATION – Matter in *italics* is new; matter in brackets ~~[omitted material]~~ is material to be omitted.

AUTHORITY: §§ 1-9, NRS 391.019 and 391.032.

A REGULATION relating to educational personnel; providing for the issuance of an interim endorsement in special education to applicants who meet certain criteria; eliminating provisions authorizing certain persons to teach pupils with disabilities in certain areas of specialization without obtaining an endorsement; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Existing law requires the Commission on Professional Standards in Education to adopt regulations prescribing the qualifications for licensing teachers and other educational personnel. (NRS 391.019) Existing law additionally requires the Commission to adopt regulations which provide for the issuance of provisional licenses to teachers and other educational personnel before the completion of all courses of study or other requirements for a license in this State. (NRS 391.032)

Existing regulations require a person to obtain an endorsement in certain areas of specialization related to special education to be eligible to teach pupils with disabilities in those areas unless an exception applies. (NAC 391.340-391.393) Existing regulations create such an exception by authorizing certain persons to teach pupils with disabilities in an area of specialization for which an endorsement is otherwise required if the person: (1) completes a program of preparation leading to licensing in the area of specialization within 3 years after beginning to teach such pupils; and (2) satisfies certain other requirements. (NAC 391.343, 391.360, 391.363, 391.367, 391.378) **Sections 3-7** of this regulation remove this authorization. **Section 1** of this regulation instead provides for the issuance of an interim endorsement in special education to an applicant who is employed by a school district or charter school in an assignment for which an endorsement in an area of specialization related to special education is otherwise required. **Sections 2-8** of this regulation authorize the holder of an interim

endorsement issued pursuant to **section 1** to teach pupils with disabilities in areas of specialization specified in **sections 2-8**.

Under **section 1**, to obtain an interim endorsement in special education, an applicant must: (1) be employed by a school district or charter school in an assignment for which an endorsement in an area of specialization related to special education is otherwise required; (2) have entered into a written agreement with the board of trustees of the school district or the governing body of the charter school that employs the applicant to complete any remaining requirements for an endorsement in the area of specialization required for his or her assignment; and (3) meet certain other requirements. An interim endorsement in special education issued pursuant to **section 1**: (1) authorizes the holder to be employed as a teacher in a public school in an assignment for which an endorsement is otherwise required; and (2) is valid for not more than 3 years. **Section 1** also: (1) requires the board of trustees of a school district or the governing body of a charter school to provide certain notice to the Office of Educator Licensure within the Department of Education if the holder of an interim endorsement ceases to be employed in the assignment for which an interim endorsement is issued; (2) prescribes requirements related to the reinstatement of an endorsement that has become invalid; and (3) provides that an interim endorsement in special education may be converted to a renewable endorsement in an area of specialization related to special education if the holder satisfies certain requirements.

**Section 9** of this regulation provides that the amendatory provisions of **sections 3-7** do not apply to a person who has been approved to teach pupils pursuant to those sections before the effective date of this regulation. **Section 9** thereby allows such a person to continue to teach pupils with disabilities in an area of specialization for which an endorsement is otherwise required without obtaining an interim endorsement.

**Section 2** of this regulation makes a conforming change to update the name of the “Council for Education of the Deaf” to reflect the current name of that entity.

**Section 7** of this regulation replaces the term “autism” with the term “autism spectrum disorder” to reflect the current terminology used in the Nevada Revised Statutes.

**Section 1.** Chapter 391 of NAC is hereby amended by adding thereto a new section to read as follows:

*1. The Superintendent of Public Instruction shall issue an interim endorsement in special education to a person who submits an application which is accompanied by proof satisfactory to the Superintendent that the applicant:*

*(a) Holds a bachelor’s degree or a more advanced degree;*

*(b) Holds a valid renewable elementary, secondary or special teaching license, a valid license to teach special education, a valid license to teach middle school or junior high school education or a valid renewable license to teach pupils in a program of early childhood*

*education;*

*(c) Is employed by a school district or charter school in an assignment for which an endorsement issued pursuant to NAC 391.340, 391.343, 391.360, 391.363, 391.367, 391.378 or*

*391.390 is otherwise required and has entered into a written agreement with the board of trustees of the school district or the governing body of the charter school, as applicable, to complete any remaining requirements for an endorsement issued pursuant to NAC 391.340, 391.343, 391.360, 391.363, 391.367, 391.378 or 391.390, as applicable, within 3 years after the date on which the interim endorsement was issued; and*

*(d) Has paid the fee required by NAC 391.045.*

*2. An interim endorsement in special education issued pursuant to this section:*

*(a) Authorizes the holder of the interim endorsement to be employed as a teacher in a public school, including, without limitation, a charter school in an assignment for which an endorsement issued pursuant to NAC 391.340, 391.343, 391.360, 391.363, 391.367, 391.378 or 391.390 is otherwise required;*

*(b) Becomes valid on the date on which the holder of the interim endorsement satisfies the requirements prescribed by subsection 1;*

*(c) Except as otherwise provided in subsection 4, is valid for not more than 3 years; and*

*(d) Is not renewable.*

*3. If the holder of an interim endorsement issued pursuant to this section ceases to be employed in the assignment described in paragraph (c) of subsection 1, the board of trustees of the school district or the governing body of the charter school with whom the holder entered into a written agreement pursuant to subsection 1 must, not later than 15 days after the holder ceases to be employed in the assignment, notify the Office of Educator Licensure within the Department of the name and license number of the holder and the date on which the holder ceased to be employed in the assignment. The interim endorsement automatically becomes invalid immediately upon the receipt of such notification by the Office of Educator Licensure.*

*4. The holder of an interim endorsement in special education that has become invalid pursuant to subsection 3 may, at any time within 1 year after the date on which the interim endorsement was issued, apply to the Superintendent of Public Instruction for the reinstatement of the endorsement if the holder:*

- (a) Resumes employment in an assignment described in paragraph (c) of subsection 1;*
- (b) Enters into the written agreement required by paragraph (c) of subsection 1; and*
- (c) Pays the fee required by NAC 391.045.*

*5. The requirements for the reinstatement of an interim endorsement in special education prescribed by subsection 4 apply regardless of whether:*

*(a) The assignment is in the same area of specialization as the area of specialization of the interim endorsement that has become invalid.*

*(b) The holder resumes employment with the same school district or charter school or obtains employment with a different school district or charter school.*

*6. An interim endorsement in special education may be reinstated pursuant to subsection 4 not more than once.*

*7. An interim endorsement in special education issued pursuant to this section may be converted to an initial endorsement issued pursuant to NAC 391.340, 391.343, 391.360, 391.363, 391.367, 391.378 or 391.390, ~~as applicable, after the completion of at least 2 full school years~~ if the holder has:*

*(a) Successfully completed the requirements set forth in the written agreement entered into pursuant to paragraph (c) of subsection 1;*

EXPLANATION – Matter in *italics* is new; matter in brackets ~~[omitted material]~~ is material to be omitted.

AUTHORITY: § 1, NRS 391.019.

A REGULATION relating to education; authorizing the Superintendent of Public Instruction to change the name of certain endorsements on licenses or to remove certain endorsements on licenses under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Existing law requires the Commission on Professional Standards in Education to adopt regulations: (1) identifying fields of specialization in teaching which require the specialized training of teachers and other educational personnel; and (2) setting forth the requirements which teachers and other educational personnel must satisfy to qualify for an endorsement in each field of specialization. (NRS 391.019) Existing regulations establish endorsements in certain areas of specialization. (NAC 391.180-391.323) This regulation authorizes the Superintendent of Public Instruction, in consultation with the Commission, to: (1) change the name of an endorsement on a license if the name of the endorsement changes; or (2) remove an endorsement from a license if the endorsement no longer exists. This regulation also authorizes a person holding a license with an endorsement that no longer exists to transition to a new endorsement under certain circumstances.

**Section 1.** Chapter 391 of NAC is hereby amended by adding thereto a new section to read as follows:

*1. If the Superintendent of Public Instruction, in consultation with the Commission, determines that:*

*(a) The name of an endorsement on a license has changed, the Superintendent shall change the name of the endorsement on the license; or*

*(b) An endorsement no longer exists, the Superintendent shall remove the endorsement on the license.*

*2. If an endorsement is removed from a license pursuant to paragraph (b) of subsection 1, the Superintendent shall allow a person holding a license to transition to an existing endorsement:*

*(a) For which the person holding a license has satisfied all the requirements, including, without limitation, course work, and authorize the person to teach in the same assignment; or*

*(b) By completing any additional requirements, including, without limitation, course work, within 3 years after the date on which the endorsement is removed.*

*3. As used in this section, “transition” means to change an endorsement on a license to a different endorsement.*

**NAC 391.391 Endorsement to teach pupils in program of orientation and mobility. ([NRS 391.019](#))**

1. To receive an endorsement to teach pupils in a program of orientation and mobility, a person must hold a:

(a) Bachelor's or graduate degree in:

(1) Orientation and mobility; or

(2) Any other field of study and have successfully completed an orientation and mobility program at a university approved by the Association for Education and Rehabilitation of the Blind and Visually Impaired or its successor organization; or

(b) Specialty credential as a Certified Orientation and Mobility Specialist from the Academy for Certification of Vision Rehabilitation and Education Professionals or its successor organization.

~~—2. Such an endorsement is not required to teach pupils in a program of orientation and mobility.~~

***New Paragraph: A person who is employed on and maintains continuous employment in a public school after the effective date of this regulation is not required to hold the endorsement.***

**NAC 391.392 Endorsement to teach program of alternative education. ([NRS 385.080](#), [391.019](#))**

1. To receive an endorsement to teach a program of alternative education, a person must:

(a) Hold a valid:

(1) Elementary license;

(2) License to teach middle school or junior high school education;

(3) Secondary license;

(4) License to teach special education; or

(5) Special license that is endorsed for a recognized field of teaching other than business and industry;

(b) Have 3 years of verified experience in teaching a program of alternative education; or

(c) Have completed at least 3 semester hours of course work in one or more of the following areas of study:

- (1) Behavior management;
- (2) Methods of teaching pupils who have specific learning disabilities;
- (3) Parental involvement in programs of alternative education; or
- (4) Methods of teaching pupils in a program of alternative education or pupils who are at risk of dropping out of school.

2. Except as limited by subsection 3, a person who holds an endorsement to teach a program of alternative education may:

(a) Provide instruction in any recognized field of teaching for which he or she holds a valid endorsement; and

(b) Teach courses outside his or her area of endorsement.

3. A person who holds an endorsement to teach a program of alternative education initially issued on or after July 1, 2005, may use that endorsement to provide instruction and teach as authorized by subsection 2 only:

(a) In an adult high school program as defined in subsection 2 of [NAC 390.480](#); or

(b) To act as a teacher of record for a pupil who is enrolled in a course of distance education which has been approved by the Department pursuant to [NRS 388.834](#) and [NAC 388.825](#).

4. ~~An endorsement to teach a program of alternative education is not required to teach a program of alternative education.~~

*New Paragraph: A person who is employed on and maintains continuous employment in a public school after the effective date of this regulation is not required to hold the endorsement.*

5. As used in this section:

(a) "Course of distance education" has the meaning ascribed to it in [NRS 388.823](#).

(b) "Program of alternative education" means:

(1) An alternative program as defined in [NAC 388.500](#); or

(2) An adult high school program as defined in subsection 2 of [NAC 390.480](#).
