Notice of Intent to Act Upon a Regulation

Notice of Hearing for the Adoption of LCB No. RO57-22

Of the

State of Nevada Board of Examiners for Marriage Family Therapists and Clinical Professional Counselors

The Board of Examiners for Marriage Family Therapists and Clinical Professional Counselors will hold a Public Hearing at 9:00 AM on Friday, August 19, 2022, at the Board Administrative Office, 7324 W. The purpose of the hearing is to receive comments from all interested parties regarding the adoption of regulations that pertain to LCB File No. RO57-22, Chapter 641A of the Nevada Administrative Code.

The proposed regulation includes the following and other matters properly relating thereto:

- NAC 641A.146 paragraph 5, subsection 2 & 5 increases the maximum allowable supervised experience hours in group therapy and training categories for licensed interns.
- NAC 641A.146 paragraph 6 removes the restriction that no credit be given for supervised practice hours gained prior to becoming an intern in the state of Nevada.
- NAC 641A.252 paragraph 1 addition of the ACA Code of Ethics to the adopted professional associations.
- NAC 641A.182 paragraph 3 addition that an approved supervisor must hold a current license in good standing in Nevada.
- NAC 641A.182 paragraph 6 addition that an approved supervisor must adhere to the supervision standards set forth by the adopted professional associations.
- NAC 641A.105 addition of clarifying language regarding the collection of fees specifically for those affiliated with the military, persons applying for a license through reciprocity and licensees requesting placement on inactive list.
- NAC 641A.243 addition of language to professional responsibility that licensees must adhere to the supervision standards set forth by the adopted professional associations.
- NAC 641A.131 addition of proration of continuing education credits needed for license renewal based on initial license issue date.

- NAC 641A.133 addition of clarifying language based on the proration of continuing education credits.
- NAC 641A new paragraph addition of language pertaining to the exemption of recordings of training activities.

The following information is provided pursuant to the requirements of NRS 233B.0603:

LCB File No. RO57-22

1. Need and purpose of the proposed regulations or amendments

The need for the proposed regulations is to protect the public health, safety, and welfare by ensuring that only qualified and competent marriage and family therapists, clinical professional counselors, marriage and family therapist interns and clinical professional counselor interns are licensed in the state.

The purpose of the adopted regulation is to provide clarity for the public, individuals, and licensees through regulations. The proposed regulation adds language that will allow an increase to the maximum allowable supervised experience hours in group therapy and training categories for licensed interns and removes the restriction that no credit be given for supervised practice hours gained prior to becoming an intern in the state of Nevada. The proposed regulation updates continuing education requirements to align with the biennial renewal cycle and adds clarifying language regarding the collection of fees specifically for those affiliated with the military, persons applying for a license through reciprocity and licensees requesting placement on inactive list. The proposed regulation adds clarifying language to supervisory qualifications.

2. How to obtain the approved or revised text of regulations prepared by LCB

3. Methods used in determining the impact on a small business

The agency used informed, reasonable judgment in determining that there will be no impact on small businesses due to the nature of the regulatory changes.

4. Estimated economic effect of regulations on business and the public

a. Adverse and beneficial effects

The adoption of these regulations should have no adverse economic effect on business, the public or practitioners of marriage and family therapy or clinical professional counseling. The benefits of these regulations are that the public and the practitioners, (marriage and family therapists, clinical professional counselors, marriage and family therapist interns and clinical professional counselor interns), will be provided clarity in NAC 641A and continuing education requirements will be consistent with the renewal term of a license. In addition, barriers to licensure are removed for marriage and family therapist interns and clinical professional counselor interns in the ability to transfer accrued hours from another state.

b. <u>Immediate and long-term effects</u>

The immediate and long-term effects of the regulations proposed in RO57-22 removes barriers to licensure for potential interns, provides clarity in the collection of fees, and provides consistency in requirements for continuing education for licensed marriage and family therapists and clinical professional counselors in Nevada.

5. Cost for enforcement of the regulations

There are no additional costs involved in enforcing the proposed regulations.

6. Overlap or duplication of other state or local governmental agencies

The proposed regulations do not overlap or duplicate any regulation of other state or local governmental entities.

7. Regulation required by federal law

Not applicable

8. More stringent than federal regulations

The Board is not aware of any similar federal regulations of the same activity in which the state regulations are more stringent.

9. New or increases in existing fees

The proposed regulations do not contain any new fees or increases in existing fees.

The Board of Examiners for Marriage Family Therapists and Clinical Professional Counselors must receive all written submissions on or before **August 19, 2022**. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board of Examiners for Marriage Family Therapists and Clinical Professional Counselors may proceed immediately to action upon any written submissions.
