### **Notice of Public Hearing for the Adoption of Proposed New Regulations of the Department of Motor Vehicles**

### **AGENDA**

The purpose of the hearing is to receive comments from all interested persons regarding the adoption of amendments that pertain to Chapter 366 of the Nevada Administrative Code.

NRS 366.203 requires the Department of Motor Vehicles to define in regulation the phrase “incidentally operated or moved upon a highway” in the context of the operation of certain vehicles using dyed special fuel. The purpose of this regulation is to comply with statute. Whereas NAC 366.0065 currently interprets the phrase as used in NRS 366.085, this regulation amends NAC 366.0065 to include the required reference to NRS 366.203.

**Note:** Items on the agenda may be taken in a different order than listed. Two or more agenda items may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the public hearing. Because of time considerations, the period for public comment by each speaker may be limited.

- Repeal of NAC 366.190; the term “federal law” is no longer used in the statute.

### **Proposed Regulations of the Department of Motor Vehicles, LCB File No R098-14**

The following information is provided pursuant to the requirements of NRS 233B.0603:

**1. The need for and the purpose of the proposed regulation or amendment.**

NRS 366.203 requires the Department of Motor Vehicles to define in regulation the phrase “incidentally operated or moved upon a highway” in the context of the operation of certain vehicles using dyed special fuel. The purpose of this regulation is to comply with statute. Whereas NAC 366.0065 currently interprets the phrase as used in NRS 366.085, this regulation amends NAC 366.0065 to include the required reference to NRS 366.203.

**2. Either the terms or the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved.**

- Addition of reference to NRS 366.203.
- Repeal of NAC 366.190; the term “federal law” is no longer used in the statute.

There is no cost to the Department in the enforcement of these proposed regulations.

If the proposed regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.**

The proposed amendments to the regulations do not overlap that of any other state, local, or federal government agency.

- 6. If the regulation is required pursuant to federal law, a citation and description of the federal law.**

These regulations are not required pursuant to federal law.

- 7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions.**

The proposed amendment does not include provisions which are more stringent than a federal regulation.

The proposed regulation does not establish a new fee or increase any existing fees.

Written submission must be received by Department of Motor Vehicles on or before **Wednesday, October 9, 2014**. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Department of Motor Vehicles may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and regulations to be adopted will be available at each of the Department of Motor Vehicles listed, and at the main public libraries listed, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at <http://leg.state.nv.us/Register/>. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
