NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Amendment of Regulations of the Governor's Office of Energy

The Governor's Office of Energy will hold a public hearing at 2:00 P.M. on August 24, 2020. Please note due to COVID-19 and social distancing requirements, this hearing will be conducted via a virtual meeting platform. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulations that pertain to chapter 701 of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. The proposed regulations are required to set minimum standards for general service lamps sold in this state pursuant to AB54 which amended NRS 701.260.
- 2. The proposed regulations set the minimum standard for general service lamps at 45 lumens per watt and clarifies what is considered within the definition of a general service lamp.
- 3. The proposed regulations are not likely to impose a direct or significant economic burden on small businesses as the market has already begun to transition to higher efficiency lighting.
- 4. There is no cost to the agency for enforcement of the proposed regulation.
- 5. The proposed regulations do not overlap or duplicate regulations of other state or local governmental agencies.
- 6. The proposed regulations are not required pursuant to federal law.
- 7. No federal regulation is applicable.
- 8. The proposed amendments do not establish a new fee or an increase to an existing fee.

Persons wishing to comment on the proposed action of the Governor's Office of Energy may appear at the scheduled public hearing or may address their comments, data, views, or arguments, in written form, to the Governor's Office of Energy, 600 E. William Street, Suite 200, Carson City, Nevada 89701. Written submissions must be received on or before Friday August 14, 2020. If no person who is directly affected by this proposed action appears to request time to make an oral presentation, the Governor's Office of Energy may proceed immediately to act upon written submissions.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

Small Business Impact Statement

In September of 2019, the Governor's Office of Energy (GOE) solicited comments via e-mail from over 300 stakeholders relative to the adoption of regulations setting minimum standards for general service lamps sold in this state on or after January 1, 2020. Per AB 54 which amended NRS 701.260, the Director shall adopt regulations and define general service lamp. The e-mail posed the following question to the stakeholders:

- 1. What is the estimated economic effect of the proposed regulation, if any, on small businesses, which these changes will regulate, including, without limitation:
 - (a) Both adverse and beneficial effects; and
 - (b) Both direct and indirect effects.

The GOE reviewed the federal lighting standards, model legislation provided by the Appliance Standards Awareness Project (ASAP) and the responses received by the stakeholders. Of the over 250 solicitations, 5 responses were received. The respondents generally stated that the changes would have no economic burden on small businesses. In fact, some of the comments stated that they were in favor of a more stringent efficiency standard for general service lamps.
