The Nevada State Library, Archives and Public Records is proposing regulation language pertaining to the Nevada Administrative Code 379.030, relating to the renewal of a certificate issued to a librarian in a public library. The proposed changes seek to revise course credit requirements in order to make librarian recertification more inclusive, applicable, and accessible.
5. (Discussion only) Workshop to Solicit Comments on Proposed Regulation updates, NAC 379.040  
The Nevada State Library, Archives and Public Records is proposing regulation language pertaining to the Nevada Administrative Code 379.040, relating to the issuance of a conditional certificate to a librarian in a public library. The proposed changes seek to revise the conditional certification application requirements in order to make librarian conditional certification more inclusive, applicable, and accessible.
