**NOTICE OF INTENT TO ACT UPON A REGULATION**

Notice of Hearing for the Adoption of Permanent Regulations of the  
Nevada Division of State Parks

**LCB File Number R-123-20**

The Nevada Division of State Parks (NDSP) will hold a public hearing to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapters 407 and 407A of the Nevada Administrative Code.

Pursuant to NRS 233B.608 and 233B.609, NDSP is providing the following statements pertaining to the public hearing on proposed changes to Chapter 407 and 407A of the Nevada Administrative Code.

The need and purpose of the proposed regulation: The purpose of the proposed regulation is to update the administration of Nevada's state parks and recreation areas in NAC 407, including updating the definitions for large all-terrain vehicles, off-highway vehicles, and creating new definitions for Nevada State Park Regions. The regulation also modifies requirements for senior citizen permits, updates entrance fees associated with veterans, establishes requirements for obtaining a photography permit, provides clarification associated with sanitation, and updates use restrictions on camping limits. Further, the regulation makes

changes to camping restrictions at Fort Churchill State Historic Park as well as camping restrictions within the Western Region state parks.

Additionally, the regulation proposes the creation of NAC 407A related to outdoor recreation. The regulation establishes procedures for the Outdoor Education and Recreation Grant Program pursuant to Assembly Bill 331 (2019).

The estimated economic effect of the proposed regulations on (a) regulated businesses and (b) the public, including, stated separately: (i) adverse and beneficial effects; and (ii) immediate and long-term effects:

(a) Regulated businesses:

(i) Adverse and beneficial effects:

NDSP anticipates no adverse effects, either direct or indirect, on regulated businesses as the result of the regulation. There will be no direct or indirect cost to regulated or small businesses. NDSP believes that there will be no beneficial effects, either direct or indirect, on regulated or small businesses as the result of these regulations.

(ii) Immediate and long-term effects:

NDSP does not anticipate any immediate effects, either adverse or beneficial, on regulated or small businesses as a result of these regulations. NDSP does not anticipate any long-term effects, either adverse or beneficial, on regulated or small businesses as a result of these regulations.

(b) The public:

(i) Adverse and beneficial effects:

NDSP views the regulation changes primarily as housekeeping and does not anticipate adverse impacts to the public as a result of these regulations. The regulation will benefit military personnel and veterans by implementing a military and veterans discount on daily entrance fees. There will be some benefit to the public by imposing a camping limit at Western Region state parks as it will open up camping spaces for more campers and reduce transients from residing/living in campgrounds in the Region. The proposed regulation will also put in place necessary general provisions for managing the Outdoor Education and Recreation Grant Program which will benefit many students in the state by providing grant for outdoor based education programs.

(ii) Immediate and long-term effects:

NDSP anticipates the immediate effects to be a clearer understanding of when a photography permit must be obtained and a reduction in the number of visitors using state park campgrounds for long term residency. There will be a reduction in unsightly, potentially hazardous, household waste being deposited through “gray water” discharge into state park campgrounds. There will be a recognition of the state’s appreciation for the nation’s armed forces through the implementation of the discount. The long-term impacts will largely be the same as the short-term effects.

The estimated cost to the Division for enforcement of the proposed regulation: NDSP does not anticipate incurring any additional cost for these proposed permanent regulations.

The proposed regulation does not overlap or duplicate any existing regulation.

The proposed regulation is not required by federal law and there is no equivalent federal law.

The proposed regulation does not establish a new fee or increase an existing fee.

Persons wishing to comment upon the proposed action of Nevada Division of State Parks may appear via virtual meeting or by telephone at the scheduled public hearing time or may address their comments, data, views or arguments, in written form to Nevada Division of State Parks, 901 S. Stewart Street #5005, Carson City, NV 89701. Written submissions must be received by Nevada Division of State Parks on or before 1:00 p.m., December 3, 2020. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, Division of State Parks may proceed immediately to act upon any written submission.

**PROPOSED REGULATION OF THE ADMINISTRATOR OF THE  
DIVISION OF STATE PARKS OF THE STATE DEPARTMENT OF  
CONSERVATION AND NATURAL RESOURCES**

**LCB File No. R123-20**

EXPLANATION – Matter in *italics* is new; matter in brackets ~~omitted material~~ is material to be omitted.

AUTHORITY: §§1-13, NRS 407.0475 and 407.065; §§14-22, 25 and 26, NRS 407A.220; §§23 and 24, NRS 407A.220 and 407A.225.

A REGULATION relating to outdoor recreation; classifying state parks into regions; revising certain requirements for obtaining a photography permit; revising certain requirements for a person 65 years or older to obtain an annual permit; revising prohibitions and restrictions relating to camping and other activities in state parks; making various other changes relating to state parks; establishing requirements for the Outdoor Education and Recreation Grant Program; establishing the membership and duties of the Technical Advisory Committee for the Grant Program; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law requires the Administrator of the Division of State Parks of the State Department of Conservation and Natural Resources to adopt regulations relating to state parks including any prohibition or restriction on activities within state parks or recreational facilities subject to the jurisdiction of the Division. (NRS 407.0475)

**Section 2** of this regulation classifies the parks in this State by region.

**Sections 3 and 9** of this regulation revise the requirements for obtaining a permit to engage in certain film or photography activities in a state park.

**Section 6** of this regulation eliminates the requirement that a person 65 years or older must have resided in this State continuously for 5 years or more to obtain an annual park permit for senior citizens.

Under existing regulations the Division will reduce the entrance fee by \$1 to persons who present a disability placard upon entrance to the park. (NAC 407.050) **Section 6** provides that the Division must also reduce the entrance fee by \$1 to persons who, upon entry to the park, are in a vehicle displaying a special license plate for persons with disabilities or a special license plate for veterans or who present a military identification card.

**Section 7** of this regulation revises the entrance fees for certain parks and sets forth the hours that the payment of a camping fee authorizes a person to use a park's camping facilities.

**Section 8** of this regulation provides that if a person camps in one or more parks in the Western region for 14 days within a 30-day period, that person is prohibited from camping in any park in the Western region for the remainder of the 30-day period.

**Section 10** of this regulation prohibits a person from placing certain wastes or hazardous substances on the ground or water of a park.

**Section 11** of this regulation prohibits a person from using an off-highway vehicle on trails or other areas of the park unless the Administrator has designated such trails or areas for use by off-highway vehicles. **Section 4** of this regulation revises the definition of "off-highway vehicle" to be consistent with the definition set forth in NRS.

**Section 12** of this regulation provides that the Administrator or his or her designee may declare a curfew for juveniles in a park rather than the ranger in charge of the region.

**Section 13** of this regulation prohibits a person from camping more than 7 days in a 30-day period in Fort Churchill State Historic Park.

Existing law establishes the Outdoor Education and Recreation Grant Program and requires the Administrator to adopt regulations for: (1) the governance of the Grant Program; and  
(2) the establishment of an advisory committee to assist the Administrator in developing and administering the Grant Program. (NRS 407A.220, 407A.225)

**Sections 16-20** of this regulation define certain terms relating to the Grant Program.

**Section 21** of this regulation sets forth: (1) the agencies, organizations, programs and other entities that are eligible to receive a grant from the Grant Program; and (2) the program activities for which grant funds may be used.

**Section 22** of this regulation provides that the Administrator may impose certain limitations on the grant money awarded under the Grant Program.

**Section 23** of this regulation sets forth the membership of the Technical Advisory Committee.

**Section 24** of this regulation sets forth the duties of the Technical Advisory Committee.

**Section 25** of this regulation requires the Administrator to review the recommendations of the Technical Advisory Committee, determine which grants to award and the amount to be awarded and post the grants awarded on the Internet website of the Division.

**Section 26** of this regulation sets forth certain requirements for a grant recipient and authorizes the Division to perform certain audits and to terminate the Division's participation in a project in certain circumstances.

**Section 1.** Chapter 407 of NAC is hereby amended by adding thereto the provisions set forth as sections 2 and 3 of this regulation.

**Sec. 2. 1.** *For the purposes of this chapter, the parks of this State are divided into the Eastern region, Southern region, Tahoe region and Western region.*

*2. The parks in the:*

*(a) Eastern region are Beaver Dam State Park, Cathedral Gorge State Park, Cave Lake State Park, Echo Canyon State Park, Elgin Schoolhouse State Historic Site, Kershaw-Ryan State Park, South Fork State Recreation Area, Spring Valley State Park, Ward Charcoal Ovens State Historic Park and Wild Horse State Recreation Area.*

*(b) Southern region are Big Bend of the Colorado State Recreation Area, Ice Age Fossils State Park, Old Las Vegas Mormon Fort State Historic Park, Spring Mountain Ranch State Park and Valley of Fire State Park.*

*(c) Tahoe region is the Lake Tahoe Nevada State Park, which consists of Marlette and Hobart Management Area, Sand Harbor, Cave Rock Management Area, Spooner Lake and Van Sickle Bi-State Park.*

*(d) Western region are Berlin-Ichthyosaur Park, Dayton State Park, Fort Churchill State Historic Park, Lahontan State Recreation Area, Mormon Station State Historic Park, Rye Patch State Recreation Area, Walker River State Recreation Area and Washoe Lake State Park.*

**Sec. 3. 1.** *Except as otherwise provided in subsection 2, a person must obtain a photography permit and pay the applicable fees set forth in NAC 407.050 for any film or photography project in a park that:*

*(a) Involves commercial photography;*



*(b) May impact the natural, cultural or recreational resources of the park or disrupt or interfere with the use and enjoyment of the park by another visitor;*

*(c) Uses actors, models, special effects, vehicles, sets or props in the park;*

*(d) Requires entry into any area of the park that is closed to visitors; or*

*(e) Requires closure of all or part of the park to other visitors.*

*2. A person is not required to obtain a photography permit:*

*(a) If the person is a reporter or other person who is employed in any news media, including, without limitation, newspapers and television, and the person enters the park to film, photograph or take an audio recording of a news event that occurs in the park; or*

*(b) For commercial photography if the person is the only person who will be in the park for the film or photography project and none of the conditions described in paragraphs (b) to (e), inclusive, of subsection 1 apply to the project.*

*3. The requirement to get a photography permit pursuant to this section is in addition to a special use permit that may be required pursuant to NAC 407.053.*

**Sec. 4.** NAC 407.0088 is hereby amended to read as follows:

407.0088 “Off-highway vehicle” ~~[means a motorized vehicle of any size that is:~~

~~—1. Operated or used exclusively off the roads or highways of this State; and~~

~~—2. Not legally equipped for operation or use on such highways.]~~ *has the meaning ascribed to it in NRS 490.060.*

**Sec. 5.** NAC 407.010 is hereby amended to read as follows:

407.010 1. The provisions of NAC 407.050 to 407.150, inclusive, *and sections 2 and 3 of this regulation* apply to all lands administered by the Division.

2. The prohibitions and restrictions of this chapter do not apply to employees of the Division while carrying out the duties of their employment.

**Sec. 6.** NAC 407.050 is hereby amended to read as follows:

407.050 1. The Division will issue a permit for senior citizens to a person who is a resident of Nevada and applies for such a permit if the person:

(a) Is 65 years of age or older;

(b) ~~Has continuously resided in this State for the 5 years immediately preceding the date on which the person submits the application;~~

~~—(e)~~ Pays a \$30 administrative fee to the Division;

~~[(d)]~~ (c) Provides proof of age and residence in Nevada to the Division; and

~~[(e)]~~ (d) Possesses a Nevada driver's license or an identification card issued by the Department of Motor Vehicles.

↪ A permit for senior citizens authorizes the holder to enter, camp in and boat in all parks for 12 months after the date the permit is issued. The permit does not authorize the use of hook-ups without payment of the fee set forth in this section.

2. The Division will issue a permit for disabled veterans to a person who is a resident of Nevada and applies for such a permit if the person:

(a) Provides proof to the Division of:

(1) A permanent service-connected disability of 10 percent or more;

(2) The status required by NRS 407.065;

(3) An honorable discharge from the Armed Forces of the United States; and

(4) Residence in Nevada; and

(b) Pays a \$30 administrative fee to the Division.

↪ A permit for disabled veterans authorizes the holder to enter, camp in and boat in all parks for 12 months after the date the permit is issued. The permit does not authorize the use of hook-ups without payment of the fee set forth in this section.

3. The Division may issue a permit that authorizes the landing of not more than two nonemergency aircraft in designated areas of a park. If the Division issues such a permit, the Division will charge a fee of \$200 per event per day for the permit.

4. The Division will charge and collect the following fees:

5. For commercial bus tours, the Division will charge and collect the established entrance fee or \$2 per person, whichever is greater, or the fee established by a special use permit. A special use permit may provide for monthly billings.

6. For each day or partial day that a person engages in ~~commercial~~ *an activity requiring a* photography *permit* in a park ~~and~~ *pursuant to section 3 of this regulation*, the Division will charge and collect the following fee according to the total number of vehicles or the total number of persons, whichever results in a higher fee:

7. A person may request an annual class A ~~commercial~~ photography permit ~~and~~ *for the activities that require a photography permit pursuant to section 3 of this regulation*. Upon approval of such a request, the Division will charge and collect from the person a fee of

\$500. An annual class A ~~commercial~~ photography permit will be recognized at all parks for 12

months after the date of issuance. A person to whom is issued an annual class A ~~commercial~~ photography permit shall:

(a) Pay the entrance fee required pursuant to NAC 407.055 each time he or she enters a park to engage in ~~commercial~~ *an activity requiring a* photography ~~[-] permit pursuant to section 3 of this regulation;~~

(b) Maintain adequate insurance coverage for the entire period he or she holds such a permit and provide proof to the Division of such coverage; ~~and~~

(c) Contact in advance the office of the park that he or she intends to use to confirm the availability of the areas where the person intends to engage in ~~commercial~~ *an activity requiring a* photography ~~[-] permit pursuant to section 3 of this regulation; and~~

*(d) Obtain a special use permit if a special use permit is required pursuant NAC 407.053.*

8. A park supervisor or regional manager in charge of a region in which a park is located may determine the area of the park that can be used under a ~~commercial~~ photography permit.

9. A person who has obtained a ~~commercial~~ photography permit may request that the Division reserve an area within the park for use on a specific day in accordance with the terms of the permit. Upon approval of such a request, the Division will charge and collect from the person a reservation fee of \$100. The reservation fee is in addition to any fee charged and collected pursuant to subsection 6 or 7.

10. The Division ~~[will]~~ *may* not charge ~~[-~~

~~—(a) A fee, other than the entrance fee for the park, pursuant to this section for photography engaged in for noncommercial, educational purposes, to promote the park.~~

~~—(b) An~~ *an* entrance fee for the park for a reporter or other person who is employed in any news media, including, without limitation, newspapers and television.

11. If a user of a park does not deposit the required fee in the available self-service devices, the Division:

(a) ~~[Will]~~ *Must* charge the user a fee of \$10 for collection service, in addition to other fees; and

(b) May file criminal charges against the user for theft as defined in NRS 205.0832.

12. For each special use permit or commercial use permit, the Division will charge a processing fee of \$25 in addition to any other fee charged for the permit.

13. The Division ~~[will]~~ *must* reduce by \$1 any entrance fee established pursuant to this chapter charged to a person who ~~[holds]~~ *upon entrance to the park:*

*(a) Presents a disability placard [and presents it upon entrance to a park.];*

*(b) Is in a vehicle displaying a special license plate for persons with disabilities;*

*(c) Is in a vehicle displaying a special license plate for veterans; or*

*(d) Presents a military identification card issued by any branch of the Armed Forces of the United States.*

**Sec. 7.** NAC 407.055 is hereby amended to read as follows:

407.055 1. Except as otherwise provided in NAC 407.050, or unless waived, the Division will charge and collect the following fees for the use of parks:

2. *A person who pays a camping fee for a park pursuant to subsection 1 is authorized to use the camping facilities of the park from 2 p.m. until 11 a.m.*

3. A person who pays an entrance fee pursuant to subsection 1 is not authorized to use the facilities of the park from 10 p.m. until 6 a.m. unless the person also pays the camping fee for the park.

*(a) Any department, division or agency of the federal government, this State or a local government.*

*(b) A federally recognized Indian tribe.*

*3. To apply for a grant, the agency, tribe, organization, program or entity must submit an application on a form provided by the Division.*

- (1) Outdoor education and recreation;*
- (2) Outdoor environmental education;*
- (3) Agricultural education;*
- (4) Natural resource-based education and recreation;*
- (5) Conservation education;*
- (6) Ecological education;*
- (7) Environmental stewardship education; or*
- (8) Environmental restoration education.*

*(b) May not be used for the following purposes:*

- (1) Activities that may reasonably be perceived to lobby or advocate for political purposes;*
- (2) Activities that would violate any local, state or federal law; or*
- (3) Organized youth sports, including, without limitation, community leagues and school teams.*

**Sec. 22. 1.** *The Administrator may establish limitations on the availability and use of grant money. Any such limitations will be set forth in the applicable application instructions.*

**2.** *The Administrator may:*

*(a) Review and approve or disapprove an application for a grant that requests less than \$5,000 instead of referring the application to the Technical Advisory Committee;*

*(b) Require that any applicant for a grant make a matching contribution to be eligible for the Grant Program; or*

*(c) Reduce the money provided from that which is requested in a grant application for any element of the grant proposal.*

**Sec. 23. 1. The Technical Advisory Committee consists of:**

*(a) The Administrator of the Division of Outdoor Recreation of the State Department of Conservation and Natural Resources; and*

*(b) The following members appointed by the Administrator of the Division of State Parks of the State Department of Conservation and Natural Resources:*

*(1) One member who represents a state agency other than the Division of State Parks or the Division of Outdoor Recreation;*

*(2) One member who represents a local government;*

*(3) One member who represents a federal agency;*

*(4) One member who represents a school district or a public school other than a charter school;*

*(5) One member who represents a private school or charter school;*

*(6) One member who represents a private nonprofit organization or community-based program, entity or organization;*

*(7) One member who represents the outdoor business community; and*

*(8) One member who has participated in an outdoor recreation and education grant program funded by a grant awarded pursuant to NRS 407A.220 or, if no such person is*

*available to serve, a person who represents pupils in this State and has knowledge and experience in outdoor education and recreation programs.*



*2. The Administrator of the Division of State Parks or his or her designee shall serve as the Executive Secretary to the Technical Advisory Committee.*

*3. Each member of the Technical Advisory Committee appointed pursuant to paragraph (b) of subsection 1 serves a term of 2 years and may be reappointed. Such members serve at the pleasure of the Administrator.*

*4. The Chair and Vice Chair of the Technical Advisory Committee shall be elected by a majority vote of the members of the Technical Advisory Committee.*

**Sec. 24.** *When evaluating completed grant applications for each periodic solicitation of grant applications, the Technical Advisory Committee shall:*

*1. Consider, without limitation:*

- (a) The eligibility requirements for a grant;*
- (b) The requirements and priorities for program selection set forth in NRS 407A.220;*
- (c) Any limitations set forth by the Administrator pursuant to section 22 of this regulation;*
- (d) The feasibility of the project; and*
- (e) The estimated costs of the program and benefits to the pupils in this State.*

*2. Rank each application received in order of priority for awarding grants. Unless otherwise required by the Administrator pursuant to section 22 of this regulation, a matching contribution is not required to apply for a grant, but applications that include a matching contribution, including, without limitation, cash or in-kind matches, may receive a higher ranking.*

*3. Recommend the amount of a grant to be awarded, if any, for a project proposed in a grant application.*

*4. Provide the Administrator with a ranked list of applicants and the recommended amount of the grant for each applicant.*

**Sec. 25. *The Administrator will:***

- 1. Except as otherwise provided in section 22 of this regulation, consider the grant applications in the order the applications were ranked by the Technical Advisory Committee;*
- 2. Determine whether to award a grant and, if applicable, in what amount the grant should be awarded; and*
- 3. Post on the Internet website of the Division any grants awarded pursuant to this section not later than 5 business days after awarding the grant.*

**Sec. 26. 1. *For each grant awarded, an agreement must be executed between the grant recipient and the Division.***

*2. Any costs incurred before an agreement is executed pursuant to subsection 1 must not be paid by the grant award unless otherwise approved by the Administrator.*

*3. Each grant recipient must:*

*(a) Submit a report to the Division as directed in the agreement executed pursuant to subsection 1;*

*(b) Certify compliance with all applicable federal and state laws and regulations; and*

*(c) Maintain accurate accounting records on the expenditure of the grant money received pursuant to sections 21 to 26, inclusive, of this regulation and provide such records to the Division in accordance with any terms set forth in the agreement executed pursuant to subsection 1 or at the request of the Division.*

*4. The Division may:*

*(a) Audit the use of grant money in accordance with generally accepted audit practices and standards; and*

*(b) Terminate the participation of the Division in any project that fails to perform in accordance with the requirements of this section.*
