**SMALL BUSINESS IMPACT STATEMENT**

Effective Date of Regulation:

**Proposed Regulation R074-25**

**REGARDING PROPOSED REGULATIONS OF THE OFFICE OF NEVADA BOARDS,  
COMMISSIONS, AND COUNCILS STANDARDS  
(NRS 233B.0608)**

I, Nikki Haag, being the duly appointed Deputy Director of the Department of Business and Industry and overseeing the Office of Nevada Boards, Commissions, and Councils Standards (Office), do hereby certify that, to the best of my knowledge and belief, the proposed regulations of the Office will not:

- (a) impose a direct or significant economic burden upon small businesses; or
- (b) directly restrict the formation, operation, or expansion of small businesses.

I further certify that a concerted effort was made by the Office pursuant to NRS 233B.0608 to determine the impact of the proposed regulations on small businesses. The following details are the findings:

---

**a. Does the proposed regulation impose a direct or indirect economic burden upon a small business.**

The Office determined that the proposed regulations are administrative in nature and apply solely to the internal governance, reporting, and operational standards of occupational and licensing boards established under NRS 232.8415(1) (a–g) and (2)(a–kk). These boards are public bodies, not private business entities. Accordingly, the proposed regulations do not impose any direct or indirect requirements, fees, or compliance obligations on small businesses.

---

**b. The manner in which the analysis was conducted.**

The Office conducted an internal review of the proposed regulations to determine whether any provision could have a direct or indirect economic impact on small businesses. Because the regulations pertain exclusively to administrative oversight, standardization of board practices, and reporting requirements within state government, no impact on small businesses was identified.

---

**c. The estimated economic effect of the proposed regulation on small businesses which it is to regulate, including both adverse and beneficial effects, and both direct and indirect effects.**

- 1. **Adverse effects:** None.
- 2. **Beneficial effects:** None.
- 3. **Direct or indirect effects:** None.

The proposed regulations do not regulate, burden, or otherwise affect any private business activities.

---

**d. Description of the methods considered to reduce the impact on small businesses and whether any were used.**

Because the proposed regulations have no impact on small businesses, no methods to reduce such an impact were considered or used.

---

**e. If the proposed regulation provides a new fee or increases an existing fee, the total annual amount expected to be collected and how the money will be used.**

The proposed regulations do not establish new fees or increase existing fees.

---

**f. The reasons for the conclusions of the agency regarding the impact of a regulation on small businesses.**

The Office concluded that the proposed regulations will not have an adverse economic effect on small businesses because:

- The regulations are strictly administrative and apply only to the internal operations of Title 54 boards and commissions.
    - The entities subject to the regulations are governmental, not commercial.
  - No new requirements, fees, or compliance obligations are imposed on private enterprises.
