**NOTICE OF WORKSHOP TO  
SOLICIT COMMENTS ON PROPOSED REGULATIONS**

The Nevada Transportation Authority ("Authority") is considering proposing the adoption, amendment, and/or repeal of regulations pertaining to Nevada Administrative Code chapter 706. An information-gathering workshop has been set for **9:30 a.m. on Thursday, August 14, 2014**. The public may attend the workshop at the offices of the Authority located at 2290 South Jones Boulevard, Suite #110, Las Vegas, NV 89146 or 1755 East Plumb Lane, Suite #216, Reno, NV 89502. The purpose of the workshop is to solicit comments from interested persons on the following general topics that may be addressed in the proposed regulations:

- 1) Revising the definition of "Bus." (NAC 706.022);
- 2) Revising the definition of "Livery Limousine" (NAC 706.080);
- 3) Revising the definition of "Prearranged" (NAC 706.1015);
- 4) Revising provisions related to the consideration of certain motor carriers that provide free shuttle service to passengers (NAC 706.147);
- 5) Revising provisions related to the payment of an electronic hailing system access fee in addition to commission or referral fees to a designated agent of a motor carrier (NAC 706.311);
- 6) Revising regulations concerning fuel surcharges assessed by charter limousine operators (NAC 706.3555);
- 7) Revising provisions concerning the population threshold of certain counties for taxicabs put into service (NAC 706.3745);
- 8) Revising provisions relating to the maximum time a taxicab maybe put into service (NAC 706.3745);
- 9) Establishing provisions permitting a hybrid vehicle acquired for the use as a taxicab to be used for an additional period of time (NAC 706.3745);
- 10) Establishing provisions related to the prohibition of carriers authorized to provide charter service by bus from staging or standing a bus in any location.

The proposal has been designated as Docket Number 13-07029 by the Authority and as File No. R061-13 by the Nevada Legislative Counsel Bureau. A copy of all materials relating to this docket may be obtained at the workshop.
