These proposed amendments have been generated to implement legislation from the 2019 Legislative Session regarding Assembly Bill 362 and to facilitate personcentered care.

The proposed regulations provide provisions for the following:

- 1. The proposed amendments are designed to allow residential facilities for groups to provide services to individual residents with dementia without obtaining a license endorsement for providing care to persons with Alzheimer's disease.
- 2. Requires providers of Residential Facility for Groups to develop a "Person-Centered Service Plan" for each resident that resides in the facility. Each plan at a minimum must include activities of daily living, medication management, cognitive safety, assistive devices, special needs, social and recreational needs, and involvement with ancillary services and must be updated at least annually.
- 3. Requires staff to have Tier 1 training within the first 40 hours of staff hire. Tier 1 is basic training needed within the for first 40 hours of staff hire including emergency response, working with clients and their families, and introduction to person centered care.
- 4. Require staff to have 8 hours of Tier 2 training within 60 days of hire. Tier 2 is more in-depth training to include psychosocial aspects of dementia, including the latest science, signs and symptoms and how to work with dementia clients.
