The purpose of the Workshop is to solicit comments on the proposed revisions to NAC 641A. The proposed regulation may include the following and other matters properly relating thereto:

NAC 641A.182 paragraph 3, new subsection – addition that an approved supervisor must complete the supervisory continuing education requirements to maintain approval.

NAC 641A.182 paragraph 4, subsection (a), number 1 – modifies that a potential primary supervisor must complete at least 100 hours of mentored supervision, which is an increase.

NAC 641A.182 paragraph 4, subsection (a), number 2 – removes that a potential primary supervisor can complete a professional training program and obtain at least 25 hours of mentored supervision.
