**SUBJECT**:

Report of Use of Restraints and Aversive Interventions

In 2009, Assembly Bill (AB) 56 amended Nevada Revised Statutes (NRS) §388.521-388.5315, which speaks to the use of mechanical and physical restraints and aversive interventions with students with disabilities (which was originally passed in 1999 as AB 280). This law requires school districts as well as private schools serving students with disabilities, to report annually to the Nevada Department of Education (NDE) on the use of permissible (i.e., emergency) and non-permissible use of physical and mechanical restraints, and aversive interventions. These reporting requirements became effective on July 1, 2009. Attached please find the statutorily required report, inclusive of all data for this reporting period (i.e., 2011-2012 school year).
