# PROPOSED REGULATION OF THE DEPARTMENT OF MOTOR VEHICLES

# NOTICE OF PUBLIC HEARING FOR THE ADOPTION OF REGULATIONS FOR THE DEPARTMENT OF MOTOR VEHICLES

The Department of Motor Vehicles will hold public workshops immediately followed by public hearings at the following locations on the dates and times specified:

Thursday, June 20<sup>th</sup>, 2002 10 a.m. Department of Wild Life Bldg. Conference Room "A" 1100 Valley Road, Reno, NV

and

Tuesday June 25<sup>th</sup>, 2002 2:00 pm Grant Sawyer Bldg Conference Room "1100" 555 East Washington Las Vegas, NV

The purpose of this hearing is to receive comments from all interested persons regarding the adoption of regulations. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Department of Motor Vehicles may proceed immediately to act upon any written submissions.

The proposed regulations amend; Chapter 482 pertaining to the completion of a Dealer Reassignment of Title Form; and reporting requirements for short-term lessors which changes the name of fee from "Rental" to "Governmental Service Fee", and requires language on a lease agreement to indicate fees as a "Recovery Surcharge".

There are no adverse short-term or long-term economic effects of the regulation on any business or on an industry as a whole.

The proposed amendment of regulations pertaining to amended Chapters of Nevada Administrative Code do not overlap or duplicate that of any other state or local governmental agency. These regulations are not required pursuant to federal law, nor does the federal government regulate similar activities.

Persons wishing to comment upon the proposed action of the Department of Motor Vehicles may appear at the scheduled public workshops and hearings or may address their comments, data, views, or arguments, in written form to Pat Bartlow, Management Services and Programs Division, 555 Wright Way, Carson City, NV 89711. Written submissions must be received by the Department of Motor Vehicles on or before June 19, 2002

A copy of this notice and the regulations to be amended will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulations to be amended will be available at each office of the Department of Motor Vehicles listed, and at the main public libraries listed, for inspection and copying by members of the public during business hours. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

# PROPOSED REGULATION OF THE DEPARTMENT OF MOTOR VEHICLES

# March 15, 2002

EXPLANATION – matter in *italics* is new, matter in brackets [omitted material] is material to be omitted.

AUTHORITY: NRS 482.313.

## Amending NAC 482.286 as follows:

- "Maintenance, preservation and examination of documents for verifying report filed with the department of taxation and the department of motor vehicles."
- 482.286. 1. Each short-term lessor shall retain records, receipts, invoices and other pertinent papers verifying the report filed with the department *of taxation and the department of motor vehicles* pursuant to paragraph (a) of subsection 2 of NRS 482.313.
- 2. Each such record, receipt, invoice and other pertinent paper must be preserved intact for at least [36 months] *four years* after the date [that] the record, receipt, invoice or paper was made.
- 3. The records, receipts, invoices and other pertinent papers must be available at all times during normal business hours for examination and copying by the department *of taxation and the department of motor vehicles* or its authorized agents.

### Amending NAC 482.288 as follows:

- "NAC 482.288 Placement of [rental] governmental services fee and recovery surcharge fee on lease agreement."
- 482.288. *1.* Each short-term lessor shall list the fee of 6 percent imposed pursuant to subsection 1 of NRS 482.313 on each lease agreement as an item on a line separated from all other listed charges, and shall identify that fee on the lease agreement as "[Rental] *Governmental Services* Fee."
- 2. If a short-term lessor charges and collects a recovery surcharge pursuant to subsection 1 of NRS 482.313, this fee shall also be listed on each lease agreement as an item on a line separated from all other listed charges, and shall identify that fee on the lease agreement as "Recovery Surcharge."

### New Language to be included in NAC 482 as follows:

- "Governmental services fees collected by the short-term lessor during the immediately preceding calendar quarter" defined. (NRS 482.313(2) b)
- "Governmental services fees collected during the immediately preceding calendar quarter," means those governmental services fees collected during the same quarter for which each quarterly report and payment is due pursuant to the provisions of NRS 482.313.

### **Definition:** "Light Duty vehicle" means:

- 1. A truck which has a gross vehicle weight rating of less than 8,500 pounds;
- 2. A motor vehicle which is subject to the laws of this state requiring registration, is capable of transporting persons and has a capacity of 15 persons or less; or
  - 3. A van conversion.
