PROPOSED REGULATION OF THE DIVISION OF INSURANCE OF THE DEPARTMENT OF BUSINESS AND INDUSTRY

NOTICE OF WORKSHOPS TO SOLICIT COMMENTS ON PROPOSED REGULATIONS

The Department of Business and Industry, Division of Insurance (Division) is proposing new regulations pertaining to prompt payment to providers; complaints; determining minimum nonforfeiture amount for annuity insurance insurers; and medical professional liability insurance. A workshop has been set for 9:00 a.m., on October 2, 2003, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested parties may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the workshop is to solicit comments from interested persons on the following general topics addressed in the proposed regulations.

- 1. Prompt Payment to Providers. The proposed regulation will amend Nevada Administrative Code (NAC) 686A.306 to clarify the reporting requirements on prompt payment to providers.
- 2. Complaints. The proposed regulation ensures that complaint procedures and carrier reporting on complaints are consistent among all licensees under Title 57 of the Nevada Revised Statutes. The new sections added address the changes made by Assembly Bill 79 of the 72nd Session of the Nevada Legislature. Chapters 695C, 695F and 695G of the NAC are amended.
- 3. Determining Minimum Nonforfeiture Amount for Annuity Insurance Insurers. Presently, chapter 688A of the Nevada Revised Statutes regulates life insurers regarding minimum nonforfeiture amounts. This regulation will extend the nonforfeiture determination compliance to include licensed insurers marketing annuity insurance pursuant to chapters 688A of the laws and regulations.
- 4. Medical Professional Liability Insurance. Disclosure requirements; statistical reporting requirements; and reporting requirements on excess judgments or settlements.
- 5. External Review Organization Certification. This regulation adds a new section to chapter 683A of the NAC as required by Assembly Bill 79 of the 72nd Session of the Nevada Legislature. The new section sets forth the provisions in which an External Review Organization is certified by the Commissioner.
- 6. Workers' Compensation Insurance (Industrial Insurance). Certification procedures, provisions and requirements for external review organizations.

NOTICE OF INTENT TO ACT UPON REGULATIONS

Notice of Hearing for the Adoption of Regulations of the Department of Business and Industry, Division of Insurance

The Department of Business and Industry, Division of Insurance (Division) will hold a public hearing at 9:00 a.m., on October 2, 2003, immediately following a public workshop, at the offices of the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Interested persons may also participate through a simultaneous video-conference conducted at the Bradley Building, 2501 East Sahara Avenue, Manufactured Housing Division Conference Room, 2nd Floor, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of:

REGULATION CONCERNING EXTERNAL REVIEW ORGANIZATION CERTIFICATION (AB 79)

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. Assembly Bill 79 of the 72nd Session of the Nevada Legislature requires the Commissioner to adopt regulations for the certification of an External Review Organization.
- 2. Assembly Bill 79 of the 72nd Session of the Nevada Legislature set forth minimal requirements for certifying an external review organization and this regulation sets forth the specifics.
- 3. (a) There is no adverse effect to the public because of this regulation. There is a beneficial effect on the public because an External Review Organization is regulated by the Division. There is a no adverse or beneficial effect to the industry being regulated.
 - (b) The immediate and long-term effect on the industry and the public is that the External Review Organizations must be certified by the Division and must follow statutory requirements.
- 4. The Division will be licensing a new category of licensee. This will require the Division to expend additional funds for enforcement.
- 5. This regulation does not overlap any other state, local government, or federal regulations.
- 6. If the regulation is required pursuant to federal law, a citation and description of the federal law: Not applicable.

- 7. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions: Not applicable.
- 8. There is a new fee:

Initial issuance of the Certification of an External Review Organization \$400 Annual Renewal fee for an External Review Organization \$100

Persons wishing to comment upon the proposed action of the Division may appear at the scheduled public hearing or may address their comments, data, views or arguments, in written form, to the Division, 788 Fairview Drive, Suite 300, Carson City, Nevada 89701. Written submissions must be received by the Division on or before September 25, 2003. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Division may proceed immediately to act upon any written submissions.

PROPOSED REGULATION OF THE DIVISION OF INSURANCE OF THE DEPARTMENT OF BUSINESS AND INDUSTRY

Proposed Regulations Regarding the Certification of an External Review Organization

Authority: Section 2 of Assembly Bill 79 of the 72nd Session of the Nevada Legislature and NRS 679B.130:

Section 1. Chapter 683A of NAC is hereby amended by adding thereto a new section to read as follows:

- 1. Each application for a certificate to be certified as an external review organization, except as provided in subsection 2 of this section, must include or be accompanied by the completed application form prescribed by the commissioner and, in addition to any other relevant information required by the commissioner, an attestation that the applicant can meet the following requirements:
- a. That the organization conducts its external review activities in accordance with the requirements of sections 16 to 28, inclusive, of Assembly Bill 79 of the 72nd Session of the Nevada Legislature, and it shall provide the following to the commissioner:
 - (1) The number of contracted external reviewers, including:
 - (a) The specialty of contracted reviewers;
 - (b) Whether it requires a contracted specialist to be board certified; and
- (c) Procedures used to ensure that each contracted reviewer has the appropriate training and experience in the field of medicine involved in the medical judgment that is being reviewed.
- (2) The procedures that it will use to ensure that a determination meets the following requirements:
 - (a) The determination is an adverse determination;
 - (b) The determination is a final determination; and
- (c) The determination is based on medical necessity pursuant to section 20 of Assembly Bill 79 of the 72nd Session of the Nevada Legislature.
- (3) The procedures that it will use to ensure that it makes its determination for an external review and an expedited external review in a timely manner pursuant to sections 22, 23 and 24 of Assembly Bill 79 of the 72nd Session of the Nevada Legislature; and
- (4) The procedures that it will use to notify the parties of its determination, including the procedures that it will use to notify the parties of its determination of an expedited external review.
- b. That the organization shall provide the following regarding conflicts of interests between the parties to the external review, pursuant to section 2 of Assembly Bill 79 of the 72nd Session of the Nevada Legislature, and it shall provide the following to the commissioner:

- (1) An attestation and the procedures that it will use to ensure that its reviewers have no conflicts of interest with the parties to the review; and
 - (2) An attestation that the organization is not affiliated with:
 - (a) A health care plan; or
 - (b) A national, state or local trade association.
- c. The applicant shall have a quality assurance plan to ensure that the organization is complying with requirements of sections 16 to 28, inclusive, of Assembly Bill 79 of the 72nd Session of the Nevada Legislature. A copy of that plan shall be provided to the commissioner.
- 2. If the organization has been accredited or certified by a national organization, the organization must submit an application prescribed by the commissioner and comply with the following:
 - a. The organization must provide the following:
- (1) Proof that it has been accredited or certified by a national accrediting or certifying organizations;
 - (2) A copy of the accreditation standards; and
- (3) A copy of the most current review that was completed by the accrediting or certifying organization.
- b. An organization that is certified by commissioner to conduct external reviews in the state based on its accreditation or certification by a national organization shall:
- (1) Immediately notify the commissioner if its national accreditation or certification organization suspends or revokes its accreditation or certification; and
- (2) A copy of the findings of any review that is conducted by the national accreditation or certification organization.
- 3. Except as otherwise provided by subsection 4, the commissioner shall issue a certificate certifying an external review organization to an application who:
 - a. Submits an application on a form prescribed by the commissioner;
 - b. Has complied with the provision of section 1 or 2 of this regulation; and
 - c. Pays the fee of \$400 for the initial issuance of a certificate.
- 4. The commissioner may refuse to issue, suspend or revoke a certificate certifying an external review organization if the commissioner determines the applicant:
 - a. Has not complied with any provisions of this regulation;
- b. Has had its license, certification, or registration denied for cause, suspended or revoked in this state or any other state;
 - c. Has misrepresented facts on its initial application or renewal application.
- 5. A certificate that is suspended or revoked must be surrendered immediately to the commissioner.
- 6. A certificate of an external review organization is valid for 1 year from the date the commissioner issues the certificate to the external review organization. Except as otherwise provided by subsection 4, an external review organization may renew a certificate if he submits to the commissioner:
 - a. A renewal application on a form prescribed by the commissioner; and
 - b. The fee of \$100 for the renewal of the certificate.
