#### **Bottled Water Plants**

### NAC 445A.547 Permits and fees required for distribution of water bottled outside Nevada.

- 1. No bottled water produced in a plant located outside of this state may be sold or distributed within this state unless the operator or distributor has obtained a permit issued by the appropriate health authority.
- 2. An applicant for such a permit must submit with his application:
- (a) A copy of the document which records the approval of the source of water by the health authority which has jurisdiction;
- (b) A copy of the permit issued to the applicant by the state or country in which his plant is located;
- (c) A report by the applicant regarding his past compliance with the applicable regulations on the quality and sampling of the water he produced or distributed;
- (d) A copy of each type of label which will be displayed with the bottled water distributed in this state:
- (e) A copy of the most recent analysis conducted pursuant to:
- (1) Paragraph (b) of subsection 1 of NAC 445A.555; and
- (2) Paragraph (c) of subsection 1 of NAC 445A.555; and
- (f) Copies of the three most recent analyses conducted pursuant to paragraph (a) of subsection 1 of NAC 445A.555.
- 3. The Health Division shall charge the applicant an application/permit fee of \$175. The fee is nonrefundable after the application has been processed by the Health Division whether or not the permit is issued.

### SMALL BUSINESS IMPACT STATEMENT

Amendments to Fees by the Bureau of Health Protection Services Contained in Nevada Administrative Code (NAC) 445A.547, 445A.589, 445A.651, NAC 445A.66635 and 445A.6664

PROPOSED AMENDMENTS TO EXISTING REGULATIONS within Nevada Administrative Code (NAC) provide for fee increases to allow the Bureau of Health Protection Services (BHPS), a bureau within the State Health Division to recover the increased costs of reviewing plans and issuing permits for bottled water plants (NAC 445A.547 and 445A.589), administering the operator certification program (NAC 445A.651), and of managing and administering the public water system supervision program (NAC 445A.66635 and NAC 445A.6664).

A small business is defined in Nevada Revised Statutes (NRS) 233B.0382 as a "business conducted for profit which employs fewer than 150 full-time or part-time employees." This statement generally applies to fees charged by the Health Division for bottled water plants, for fees charged to water system operators for certification, for annual permits issued to public water systems, and for fees charged for the review and approval of water projects of public water systems. See the Small Business Impact Statement for regulatory amendments to Chapter 278 of the NAC for a similar discussion of the impacts of fee increases related to the review of subdivision tentative and final maps.

### **Background**

The State Health Division receives funding for BHPS from three primary sources: grants from the federal government for administering the Public Water System Supervision Program; fees from regulated entities; and General Fund appropriations by the Nevada State Legislature. Nevada's allotment of the primary federal grant has decreased in recent years while expenses have increased. The federal grant, which is limited to the management and administration of the Public Water System Supervision Program, provides a major portion of the revenues to support the Public Health Engineering Section. Additional revenue from fees and General Fund appropriations provide the required match for the federal grants and supplemental revenue to meet remaining expenses. Since the review of bottled water plants is a state, not a federal, requirement, federal funds do not provide revenue to support this work. The only sources of revenue for this section are from fees and General Fund appropriations.

The Health Division has statutory responsibilities defined in NRS 439 and 445A that provide for review and permitting of bottled water plants. It has statutory responsibility defined in NRS 445A that provides for annual permits, for the purposes of administering the public water system supervision program, which includes issuing annual permits, reviewing plans of water projects, and administering an operator certification program. Corresponding sections of the NAC 445A provide the regulatory framework under which these duties are carried out by the BHPS. BHPS

collects fees for the purpose of administering these regulations, but the collected fees do not cover the actual cost of the BHPS performing these statutory responsibilities.

While the Nevada State Legislature appropriates varying levels of funds for all of these purposes, the combined federal and state funding does not cover the actual cost of the Bureau performing these statutory responsibilities. To meet this funding shortfall, and to provide program enhancements, the Nevada State Legislature has historically required that regulated entities pay fees to the State Health Division to supplement the funding for BHPS. (See NRS 439.150.) In State Fiscal Year 04 (July 1, 2003 — June 30, 2004) and State Fiscal Year 05 (July 1, 2004— June 30, 2005), the Nevada State Legislature has budgeted a fee increase of approximately \$208,000 just to provide funding for the work performed by Public Health Engineering and Environmental Health Sections performed of the BHPS.

The federal Safe Drinking Water Act, as amended in 1996 (42 United States Code §§300f et seq), provides specifically for assistance to smaller systems serving less than 10,000 consumers. The Health Division's position in addressing fee increases for public water systems is consistent with this approach and recognizes the federal and state funding as a subsidy for costs to administer the public water system supervision program, especially for the smaller systems.

The proposed amendment to NAC 445A.547 adds a new application/permit fee of \$175 for bottled water purveyors which bottle water outside of Nevada, but distribute water in Nevada. The proposed amendment to NAC 445A.259 increases the annual permit fee to operate a plant in Nevada from \$100 to \$150; to review plans for constructing a plant from \$100 to \$200; and to review plans for remodeling a permitted plant from\$50 to \$100. The proposed amendment to NAC 445A.651 raises the fees generally increases fees for the operator certification program (testing, issuing and renewal of an operator certificate). The changes to NAC 445A.66635 clarify wording to correspond with changes to NAC 445A.6664. Although the impacts to individual privately-owned, public water systems are difficult, if not impossible, to quantify, the following impacts due to proposed changes in NAC 445A.6664 may be expected.

- Operator certification fees increase between \$5 and \$44 for certain types of applications
  to cover the cost of tests, postage and administrative costs to administer the operator
  certification program.
- Plan review fees for subdivision tentative maps and for final maps and associated water project improvement plans, and for other water project plans (i.e., distribution, transmission, storage, treatment) will also increase.
- The formula for charging fees for annual permits is proposed to be revised from a "stepped" system to a fee system prorated on service connections for all public water systems serving more than 25 connections. The existing "stepped" fee system has been in effect since at least 1992. For community and noncommunity public water systems serving fewer than 25 connections, the fee would be unchanged. For public water systems serving more than 26 connections, the fee would be generally be less than currently charged.
- A new annual permit fee for treatment plants would be implemented. The impact of this fee is unknown, but will affect those public water systems that either have existing water

treatment plants, or expect to have install treatment as a result of new drinking water regulation requirements (such as for arsenic).

# 1. A description of the manner in which comment was solicited from affected small businesses, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.

Letters were sent to all affected public water systems as well as those engineering firms who normally do business with the BHPS and local health authorities advising them of the potential fee changes and providing notice of public workshops. Copies of the proposed amendments will be posted at the Health Division's web site. Public workshops were held in September 2003 and are scheduled again for October 28, 2003. Copies of proposed amendments have been provided to those individuals and businesses, which have requested direct service.

Several faxed responses and numerous phone calls provided initial general responses to the generic questionnaire included in the mass mailing, which included fee amendments to nine Chapters of the NAC. Generally, many responders, whether or not they met the definition of a small business, complained that any increase in state fees was an increase in consumer fees, which was an adverse impact, and therefore not warranted. Although many of the responses were not specific to the changes proposed in NAC 445A, the following did appear to address the proposal. Some indicated that they doubted very much if they would see any beneficial effects. Some indicated that the increase in fees would erode already slim profit margins. Several respondents indicated that an increase in water system fees would have an adverse economic impact, and that an increase in operator certification fees would make it harder to qualify and hire operators. Generally, responders did not recognize that annual permit fees for smaller water systems would actually decrease; when that was clarified for those that phoned, they were somewhat mollified

## 2. The estimated economic effect of the proposed regulation on the small business which it is to regulate including, without limitation, both adverse and beneficial effects and both direct and indirect effects.

Direct Adverse and Beneficial Effects

A potential direct adverse effect may be that some small privately-owned, public water systems and some engineering firms will experience increased costs for plan reviews of subdivisions, water projects, and treatment facilities. Fees for bottled water plants, both in-state and out-of-state will increase. A beneficial direct effect is that costs for annual permits should decrease for some privately-owned, public water systems. Overall, better service to those entities affected should result from adequate funding of BHPS administrative activities.

The estimated direct and indirect beneficial economic effects of the proposed fee changes on affected small businesses cannot be quantified. Fee decreases for annual permits will be generally lower for small systems, so that should be beneficial. Overall, an indirect beneficial effect of the proposed fees will be that adequate funding for better protection of the health and safety of Nevada residents and tourists by decreasing the possibility of contamination of the public water supply, and ensuring the safe drinking water.

#### **Direct and Indirect Costs**

The estimated direct adverse economic effect of the proposed fee increases on the public water systems that qualify as small businesses, although unknown, is not expected to be large and will primarily occur in the plan review process and the annual permits for treatment facilities. Indirect costs may be incurred by the customers of those systems in that the costs might be passed through to rates. Costs would be determined on a case-by-case basis.

## 3. A description of the methods that BHPS considered to reduce the impact of the proposed regulation on small businesses and statement regarding whether the agency actually used those methods.

In considering methods to reduce the impact of the proposed regulation on small businesses as required by NRS 233B.0608 2 (b) (1), the agency shall consider simplifying the proposed regulation.

This fee proposal does not propose new regulations for compliance. The impact of these fee increases on small businesses has been minimized or eliminated to the extent possible. New fees are implemented, or existing ones increased in those areas where BHPS has experienced or expects increased activity and, therefore, increased costs. However, fees must be increased based upon the legislatively approved budget for BHPS's regulatory responsibilities.

In considering methods to reduce the impact of the proposed regulation on small businesses as required by NRS 233B.0608 2 (b) (2), the agency shall consider establishing different standards of compliance for a small business.

This fee proposal does not propose new regulations for compliance.

In considering methods to reduce the impact of the proposed regulation on small businesses as required by NRS 233B.0608 (2)(b)(3), the agency shall consider modifying a fee or fine set forth in the regulation so that a small business is authorized to pay a lower fee or fine.

Annual permit fees for small businesses have been decreased to the extent possible by taking into account the availability of federal and state funds to regulate small public water system.

### 4. The estimated cost to the agency for enforcement of the proposed regulation.

The estimated cost to the agency for enforcement of the proposed regulation is minimal and will be handled through the existing administrative process. Some changes in the fee system and operator certification (Safe Drinking Water Information System) modules may be required.

### 5. Total amount BHPS expects to collect from any fees and the manner in which the money will be used.

The total amount of revenue expected to be collected from this fee proposal in Chapter 445A of the NAC is estimated at \$405,739, an increase of about \$89,599 over existing revenue. This additional revenue (\$78,549 for Public Health Engineering and \$11,050 for Environmental Health Services) will be used to purchase needed equipment, and to provide additional funds for salaries in order to improve the administration of the affected programs.

6. An explanation of why any duplicative or more stringent provisions than federal, state or local standards regulating the same activity are necessary.

The proposed fee changes do not overlap or duplicate any federal, state or local regulations.
