NOTICE OF INTENT TO AMEND REGULATIONS

Authority—NRS 564.080 as amended in 2003.

Hereby propose an Amendment to NAC 564.010, by adding a section pertaining to fees for processing and continued administration of a security agreement, etc, pertaining to a brand or mark.

Sec. 4. The fee for processing and continued administration of a security agreement, provisional assignment or legal lien relating to a brand or brand and mark or marks of record shall be \$35 each year beginning July 1 and ending June 30. The fee must not be prorated for any unused portion of the year for which the processing and continued administration of a security agreement, provisional assignment or legal lien relating to a brand or brand and mark or marks of record shall be required.

Need and purpose of the proposed amendment:

To aid the Division of Livestock Identification (a fee based agency) in more adequately meeting the costs of operations, brand inspector's salaries and travel costs.

Economic effect of the proposed amendment on businesses which it is to regulate:

- 1) Adverse effects: None
- 2) Beneficial effects: None
- 3) Immediate and long-term economic effects: Same

Economic cost to the agency for enforcement of the amendment: There will be no additional cost to the agency for the enforcement of the amendment.

Description of any regulations of any other state, local or federal regulation that the proposed amendment overlaps or duplicates: There are none.

Fees: The proposed amendment contains a fee for services rendered. This fee will generate approximately \$5000-7500 in additional revenue to the Division of Livestock Identification to be used to fund salaries and travel of deputy brand inspectors. The fee will provide incentive for lenders to keep the Division appraised of the status of any such liens.
