Purpose: To adopt regulations under chapter 670 of the Nevada Administrative Code relating

to development corporations by establishing the amount of certain fees; providing for certain definitions and policies; and providing other matters properly relating

thereto.

Sec. 1. Chapter 670 of the NAC is hereby amended by adding thereto the provisions set forth as sections 2 through 5, inclusive, of this regulation.

Sec. 2. NAC 670.010 is hereby amended as follows:

NAC 670.010 Fee for supervision and related activities: Amount; collection; failure to pay. (NRS 658.101, 670.067, 670.250)

The Commissioner of Financial Institutions will charge and collect a fee of [\$30] \$100 per hour from each development corporation for any supervision, examination, audit, investigation or hearing conducted pursuant to chapter 670 of NRS.

- **Sec. 3**. NAC 670.020 is hereby amended as follows:
- **NAC 670.020 Fees: Application for license to conduct business.** (NRS 670.067, 670.115) An application to conduct business as a development corporation submitted pursuant to NRS 670.115 must be accompanied by:
 - 1. [A] The nonrefundable fee [of] required by NRS 670.115(2) is [\$1,500] \$2,000; and
- 2. [A fee of \$300, prorated by the Commissioner of Financial Institutions.] The prorated fee required by NRS 669.115(2) shall not be less than \$500.
- Sec. 4. NAC 670.030 is hereby amended as follows:
- NAC 670.030 Fees: Renewal of license; reinstatement of expired license. (NRS 670.067, 670.240)
- 1. [A licensed development corporation shall pay annually to the Division of Financial Institutions of the Department of Business and Industry a fee of \$375 for the renewal of the license.] The annual licensing renewal fee required pursuant to NRS 670.240(1) is \$500.
- 2. [If the Commissioner of Financial Institutions reinstates an expired license, the licensee shall pay a reinstatement fee of \$300 in addition to the annual renewal fee prescribed in subsection 1.] The reinstatement fee required pursuant to NRS 670.240(1) is \$400.
- Sec. 5. Confidentiality of Financial Records, Applications and Examinations. (NRS 670.250) The application and financial records submitted by a person pursuant to the provision of this chapter, any financial records or other documents submitted by a licensee pursuant to an audit or examination conducted by the Division and any report of examination by the Division are confidential and may be disclosed only to:
 - 1. The Division;
- 2. An authorized employee of the Division who needs the records for purposes relating to the administration of this chapter; or
- 3. A person or governmental entity that is authorized to obtain the records pursuant to an order issued by a court of competent jurisdiction.
