Proposed Regulation of the Department of Motor Vehicles, LCB File No. R150-08

This is a regulation relating to the Department of Motor Vehicles, Motor Carrier Division amending Chapters 360A, 365, and 366 of the Nevada Administrative Code (NAC) to comply

with Legislation passed during the 2007 Legislative Session. The proposed amendments revise certain licensing procedures and establish administrative fines for late license renewal applications submitted to the Department by dealers, suppliers, exporters and transporters. In addition, the proposed amendments also revise provisions when claiming certain tax refunds on exempt uses of various types of fuels.

The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to chapters 360A, 365, and 366 of the Nevada Administrative Code.

Proposed Regulation of the Department of Motor Vehicles, LCB File No. R150-08

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment:

This is a regulation relating to the Department of Motor Vehicles, Motor Carrier Division, amending Chapters 360A, 365, and 366 of the Nevada Administrative Code

(NAC) to comply with Legislation passed during the 2007 Legislative Session. The amendments proposed in this regulation make various changes relating to the payment of certain taxes and fees imposed on motor vehicle fuel, aircraft fuel, and special fuels. The proposed amendments revise certain licensing procedures and establish administrative fines for late license renewal applications submitted to the Department by dealers, suppliers, exporters, and transporters. In addition, the proposed amendments also revise provisions when claiming certain tax refunds on exempt uses of various types of fuel.

2. Either the terms or the substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved:

The Department is required by statute to amend regulations relating to the administration and the enforcement of the taxation of motor vehicle fuel, aircraft fuel and special fuels.

- 3. The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include: (a) Both adverse and beneficial effects (None) and (b) Both immediate and long-term effects (None). There is no estimated economic effect.
- **4.** The estimated cost to the agency for enforcement of the proposed regulation: There is no cost to the agency in the enforcement of the proposed regulations.

Written submission must be received by Department of Motor Vehicles on or before **Tuesday**, **November 25, 2008.** If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Department of Motor Vehicles may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be amended will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and regulations to be Amended and Repealed will be available at each of the Department of Motor Vehicles listed, and at the main public libraries listed, for inspection and copying by members of the public during business hours.
