## PROPOSED REGULATION OF THE DIRECTOR OF THE DEPARTMENT OF ADMINISTRATION AND THE ATTORNEY GENERAL

## **Collection of Debts**

September 2, 2008

EXPLANATION – Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted.

Purpose: To improve the process of collecting debts owed to agencies of the Executive Branch of the State of Nevada.

Authority: NRS 353C.110

- **Section 1.** Chapter 353C of the Nevada Administrative Code is hereby amended by adding thereto sections 2 to 4, inclusive, of these proposed regulations.
- Sec. 2. "Agency debt" means a debt that has been assigned to the Controller for collection pursuant to Section \_\_\_\_ of these proposed regulations.
- Sec. 3. The Controller shall consider a debt to be contested by the debtor if the debtor or his agent disputes the existence of the debt or its amount.

- Sec. 4. When the Controller acts as the collection agent for the agency the agency must:
- 1. pay the Controller \$10 for each debt assigned for collection to off-set the Controller's costs in collecting the debt;
- 2. agree to report to the Controller all agency debts that are or become past due for 60 days or more;
  - 3. authorize the Controller to exercise reasonable discretion to:
  - (a) collect the debt including, but not limited to, sending letters to the debtor, entering into installment agreements for the payment of the debt, filing claims in bankruptcy, seeking a certificate of liability pursuant to NRS 353C.180 or a summary judgment pursuant to NRS 353C.150, or off-setting the debt against any credit due to debtor pursuant to NRS 353C.210;
  - (b) enter into agreements with a private debt collector to collect the agency debts as authorized by NRS 353C.200;
  - (c) retain any interest earned on installment agreements for the repayment of agency debts to off-set the Controller's costs of collecting agency debts;
  - (d) if authorized by law, use a portion of the proceeds of debts collected to off-set the actual cost of collecting the debt if the Controller determines it to be in the best interests of the State to incur those costs to collect the debt;
    - (e) post a list of debtors and debts owed the State on the Internet;
  - (f) request the Board of Examiners on the agency's behalf to declare that the agency debt is a bad debt pursuant to NRS 353C.220
  - (g) return to the agency debts which, in the Controller's judgment, are contested by the debtor.

## **Sec. 5.** NAC 353C.200 is hereby amended to read as follows:

The Controller or his designee may consider any issue relevant to a determination of the legality of the requested offset pursuant to NAC 353C.100 to 353C.140, inclusive. [The scope of the hearings excludes review of the final determination of the amount due an agency from the petitioner.]
