# NOTICE OF PUBLIC HEARING FOR THE ADOPTION AND AMENDMENT OF PERMANENT REGULATIONS OF THE NEVADA STATE BOARD OF COSMETOLOGY

The Nevada State Board of Cosmetology will hold a public hearing on **Monday**, **May 19th at 9:00 a.m.** via Video-Conferencing and Teleconferencing at the following locations:

The Nevada State Board of Cosmetology will receive testimony from all interested persons and consider and take action on the following proposed adoption of amendments, additions and

deletions to the Nevada Administrative Code (NAC) pertaining to the State Board of Cosmetology as more detailed and defined in LCB File Number R106-12. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the State Board of Cosmetology may proceed immediately to act upon any written submissions:

# 1. The Need for and Purpose of the Proposed Permanent Regulations.

The need and purpose of the proposed permanent regulations are to implement changes in NAC Chapter 644 with regard to various procedural and operational processes, and to set forth and clarify substantive procedural matters for administration of the regulations.

# 2. Terms or Substance of the Proposed Permanent Regulations or Description of the Subjects and Issues Involved.

First - prohibiting a licensed cosmetologist who supervises and trains a cosmetologist's apprentice or a licensed electrologist who supervises and trains an electrologist's apprentice from receiving compensation for the apprenticeship

Second - revising provisions governing practice before the State Board of Cosmetology Third - revising provisions governing the submission of complaints to the Board and determination by the Executive Director of the Board whether a complaint warrants an investigation

Fourth - revising the procedure for petitioning the Board for a declaratory order or an advisory opinion

Fifth - requiring a petitioner to comply with the provisions of a declaratory order or advisory opinion issued by the Board

Sixth - revising provisions governing the procedure for a petition for the adoption, filing, amendment or repeal of a regulation

Seventh - revising certain provisions concerning mobile cosmetological establishments Eighth - prescribing fines for certain violations

Ninth - prescribing conduct which constitutes gross malpractice

Tenth - prescribing certain conduct for which a licensee is subject to disciplinary action

Eleventh - repealing certain provisions governing practice before the Board

Twelfth - providing other matters properly relating thereto

# 3. Estimated Economic Effect of the Proposed Permanent Regulations on Small Business.

The proposed permanent regulation has no adverse economic effect on the Nevada State Board of Cosmetology, the licensed cosmetology professionals, licensed cosmetological establishments, licensed cosmetology schools, or the public. The regulation has no negative impact on Small Business. The permanent regulation could have a beneficial economic effect on the Board of Cosmetology, Small Business, and the public. The regulation should enable the public and licensed entities the ability to clearly understand the procedure for lodging complaints and petitioning the Board of Cosmetology reducing the time to enable these processes. It will

also enable the reduction of illegal, non-licensed activities through the proposed fining system for false and deceptive advertising, thus increasing the potential clientele for all licensed cosmetology professionals. The regulation could benefit Small Business through a clear process for obtaining a license for a mobile cosmetological establishment.

## 4. Estimated Cost to Agency for Enforcement of Proposed Permanent Regulations.

The proposed permanent regulation will present no additional incremental cost to the State Board of Cosmetology in administering these new regulations.

# 5. Regulations of Other State or Local Governmental Agencies which the Proposed Permanent Regulations Overlap or Duplicate and the Necessity Therefore.

The proposed permanent regulations do not appear to overlap or duplicate regulations of other state or local governmental agencies.

### 6. Establishment of New Fee or Existing Fee Increase.

The permanent regulations would not increase any existing fee or create any new fees. There are new fines associated with citations issued for violating sections of NRS 644 and NAC 644. Since these new fines are initiated upon a violation of laws and regulations, the licensed cosmetology professionals who obey the law would never have to pay one of these fines.

Persons wishing to comment on the proposed action of the State Board of Cosmetology may appear at the above scheduled public hearing or may address their comments, views, or arguments, in written form, to the Nevada State Board of Cosmetology, 1785 E. Sahara Avenue, Suite 255, Las Vegas, Nevada 89104. Written submissions must be received by the Nevada State Board of Cosmetology on or before May 12, 2014. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Nevada State Board of Cosmetology may proceed immediately to act upon any written submissions.

A copy of this notice and the proposed permanent regulations to be adopted and amended will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the

Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us.

The text of the proposed permanent regulations will include the entire text of any section of the Nevada Administrative Code, which is proposed for amendment or repeal. Copies will be mailed to members of the public upon request. A reasonable fee may be charged for copies if deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
