Notice of Hearing for the Adoption, Amendment or Repeal of Regulations of The Department of Business and Industry, Division of Insurance

The State of Nevada Department of Business and Industry, Division of Insurance ("Division"), (775) 687-0700, will hold a public hearing at **9:30 a.m. on November 13, 2013,** at the Division's office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706. Interested persons may also participate through a simultaneous videoconference conducted at the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of the regulation(s) that pertain(s) to **chapter 690B** of the Nevada Administrative Code ("NAC").

The following information is provided pursuant to the requirements of Nevada Revised Statute ("NRS") 233B.0603 and the directives of the Governor:

LCB File No. R067-13. Limited Automobile Policy Disclosure.

A regulation relating to casualty insurance; revising provisions relating to certain notices for policies of automobile insurance; and providing other matters properly relating thereto.

- (1) Why is the regulation necessary and what is its purpose? This proposed regulation is considered housekeeping and is necessary to be consistent with today's electronic environment. The current regulation specifies an exact method for providing notice when an automobile policy does not include public liability coverage. This proposed regulation retains the notice requirement while eliminating outdated printing requirements.
- (2) What are the terms or substance of the proposed regulation? The current regulation requires a notice to be **imprinted**, **stamped**, **or placed as a sticker in red 14-point or larger text on the face of a policy** when an automobile policy does not include liability coverage. The proposed regulation amends NAC 690B.310 to require the notice to be prominently displayed on the declarations page. The currently prescribed method of display may be cumbersome to the insurer and is unnecessary in this modern word processing environment.
- (3) What is the anticipated impact of the regulation on the problem(s)? The proposed regulation will provide insurers with more flexibility in providing insureds the required information.
- (4) Do other regulations address the same problem(s)? No.
