NOTICE OF PUBLIC HEARING

Intent to Adopt Regulations (LCB File No. R100-13)

NOTICE IS HEREBY GIVEN that the State Board of Health will hold a public hearing to consider an amendment to Chapter 457 of Nevada Administrative Code (NAC), Cancer, Specifically to Mammography. This public hearing is to be held in conjunction with the State Board of Health meeting on December 13, 2013. The NAC 457 regulation change will be heard in the order placed on the State Board of Health agenda.

The proposed changes to NAC 457 include the following:

- 1. Anticipated effects on the business which NAC 457 regulates:
 - A. Adverse effects: No adverse effects have been identified.
 - B. Beneficial: Enhanced communication between providers and patients.
 - C. *Immediate*: Positive communication between providers and specialists. More informed patients, involved in directing their care.
 - D. *Long-term*: Better follow of patients who may be having pathology, but not be symptomatic.
- 2. Anticipated effects on the public:
 - A. Adverse: None anticipated.
 - B. *Beneficial*: Anticipated benefits to patients will be advising them of the limitations of their mammography exam and options possibly available.

- C. *Immediate:* Increased patient involvement. More informed patients, involved in directing their care.
- D. *Long-term:* Further investigation may reveal hidden pathologies otherwise not diagnosed; thence early discovery leads to improved survival rate.
- 3. The estimated cost to the Division of Public and Behavioral Health for enforcement of the regulations is none. This will be incorporated into part of the usual yearly inspection process of reviewing reports. The monetary penalty section of the proposed regulations is not expected to be an issue as staff already performs this function. Compliance within the industry is good and no issues are expected.

The proposed regulations do not overlap or duplicate any other Nevada state regulations or federal regulations.

Members of the public may make oral comments at this meeting. Persons wishing to submit written testimony or documentary evidence in excess of two typed, 8-1/2" x 11" pages must submit the material to the Board's Secretary, Richard Whitley, to be received no later than December 2, 2013 at the following address:

SMALL BUSINESS IMPACT STATEMENT 2013 PROPOSED AMENDMENTS TO NAC 457

The Division of Public and Behavioral Health (DPBH) has determined that the proposed amendments should not impose an economic burden upon a small business or have a negative impact on the formation, operation or expansion of a small business in Nevada.

A small business is defined in Nevada Revised Statutes NRS 233B as a "business conducted for profit which employs fewer than 150 full-time or part-time employees."

This small business impact statement complies with the requirements of NRS 233B.0609.

1) A description of the manner in which comment was solicited from affected small businesses, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.

Background

During the 2013 Legislature, Assembly Bill 147 was passed in the interest of public health. AB 147 concerns the reporting requirements for mammographic examinations which demonstrate dense breast tissue. This bill was heard in the 2013 legislative session and public input was elicited and taken into consideration by the legislators. It passed and was signed into statute by Governor Sandoval.

AB 147 in similar form has been passed in many other states as noted in the bill. As you may be aware, the concern is that dense breast tissue 'may' mask pathology not visible on the mammographic examination. This regulation addresses the need for physician interpreters qualified under the NAC 457 and MQSA (Mammography Quality Standards Act) under 21 CPR part 900 to report the finding and relevance of dense breast issue to referring providers and to the patients in a letter that the patient can understand, suggesting possible use of other exploratory options that may be utilized as deemed necessary by the provider in consultation with the patient.

Pursuant to NRS 233B.0608 (2) (a), the Division of Public and Behavioral Health has requested input from mammography facilities.

A Small Business Impact Questionnaire was sent to mammography facilities along with a copy of the proposed regulation changes, on October 2, 2013. The questions on the questionnaire were:

- 1) How many employees are currently employed by your business?
- 2) Will a specific regulation have an adverse economic effect upon your business?
- 3) Will the regulation(s) have any beneficial effect upon your business?
- 4) Do you anticipate any indirect adverse effects upon your business?
- 5) Do you anticipate any indirect beneficial effects upon your business?

2) The manner in which analysis was conducted.

Karen Beckley, Manager, Radiation Control Program, in consultation with Adrian Howe, Supervisor, Radiation Control Program and Ed Sweeten, Supervisor, Radiation Control Program, conducted the analysis of the impact on business. The analysis considered the questionnaire answers and comments as well as past business practices of the regulated industry. Based upon this consideration the agency is following the directive of the legislature and is relying on their expertise in limiting the impact on small business.

3) A description of the methods that DPBH considered to reduce the impact of the proposed regulation on small businesses and statement regarding whether the agency actually used those methods.

The Division of Public and Behavioral Health has held several opportunities for the public and the regulated community to provide comments regarding the proposed NAC 457 regulations, including the economic impact the proposed regulations may have. No modifications to the proposed regulations have been made as a result of this input. Workshops will be held on October 18, 2013 allowing for further input by the public, regulated community or other interested parties regarding the proposed regulations and their any impact. These comments will be taken into consideration for possible further revisions to the regulations to reduce the economic impact on facilities.

4) The estimated cost to the agency for enforcement of the proposed regulation.

At this time, there is no estimated cost to the agency for enforcement of the proposed regulation as it can be incorporated into the inspection process.

5) Total amount DPBH expects to collect from any fees and the manner in which the money will be used.

There is no additional funding attached to this regulation.

6) An explanation of why any duplicative or more stringent provisions than federal, state or local standards regulating the same activity are necessary.

At this time there are no duplicative provisions. What necessitated these regulations to be adopted was to require facilities and mammographers to ensure that the public is notified of dense breast tissue issues and what course of action for additional diagnostic evaluations may or may not be of benefit to the patient.

7) The reasons for the conclusions of the agency regarding the impact of a regulation on small businesses.

AB 147 and the proposed regulations require that an additional notification regarding dense breast tissue issues be added to a letter already required by regulation to the patient. The agency received only one comment of a negative impact on small business with no evidence offered as to the nature of the perceived impact.
