PROPOSED REGULATION OF THE BOARD OF WILDLIFE COMMISSIONERS

LCB File No. R087-14

COMMISSION GENERAL REGULATION 450

EXPLANATION – Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted.

AUTHORITY: §§1 and 2, NRS 501.105, 501.181, and 503.570.

A REGULATION relating to trapping; specifying the minimum period during which a person must visit or cause to be visited certain traps, snares or similar devices.

Section 1. NAC 503.152 is herby amended to read as follows:

503.152 A person who is required pursuant to NRS 503.570 to visit or cause to be visited a trap, snare or similar device shall ensure that the trap, snare or similar device is visited at least:

- 1. Once each calendar day in the following Wildlife Management Units, as defined in NAC 504.210, or portions thereof so described in section 1, excluding private property:
 - a. All of Unit 192;
 - b. All of Unit 194;
- c. That portion of Unit 195 west of Lagomarcino Canyon-Lousetown Road from its intersection with Interstate 80 to its intersection with State Route No. 341 and State Route No. 341 from its intersection with Lousetown Road to its intersection with U.S. Highway No. 50;
 - d. All of Unit 196;
 - e. That portion of Unit 286 outside of the Desert National Wildlife Refuge;
- f. That portion of Unit 262 south of State Route No. 157 (Kyle Canyon Road) from its intersection with U.S. Highway No. 95 to the Cathedral Rock Trail trailhead; east of the Charleston Peak Trail South Loop from the Cathedral Rock Trail trailhead to the summit of the Spring Mountains ridgeline, the Spring Mountains ridgeline that runs south from the Charleston Peak Trail South Loop to Griffith Peak and continuing to Lovell Summit, the unimproved dirt road from Lovell Summit to its intersection with Lovell Canyon Road, and Lovell Canyon Road from its intersection with the unimproved dirt road from Lovell Summit to its intersection with State Route No. 160; north of State Route 160 from its intersection with Lovell Canyon Road to its intersection with Interstate 15; and within ½ mile west of U.S. Highway No. 95 from its intersection with State Route No. 157 (Kyle Canyon Road) to its intersection with Cold Creek Road, ½ mile north and west of State Route No. 157 (Kyle Canyon Road), ½ mile either side of State Route No. 158 (Deer Springs Road), ½ mile either side of State Route No. 156 (Lee Canyon Road), ½ mile either side of Cold Creek Road, and ½ mile of residences in the Cold Creek community;
- g. That portion of Unit 263 north of the unimproved dirt road from Interstate 15 to the western boundary of the Sloan Canyon National Conservation Area and the western, southern, and eastern boundary of the Sloan Canyon National Conservation Area from the unimproved dirt road from Interstate 15 to the southern boundary of the Clark County Illegal

Firearm Discharge Area and the southern boundary of the Clark County Illegal Firearm Discharge Area from the eastern boundary of the Sloan Canyon National Conservation Area to U.S. Highway No. 95, excluding the North McCullough Wilderness Area;

- h. That portion of Unit 268 within the Clark County Illegal Firearm Discharge Area; and
 - j. All of Unit 269;
- 2. Once each 96 hours in all other Wildlife Management Units, as defined in NAC 504.210, or portions thereof not included in section 1;
 - 11 3. By a person who is a holder of a trapping license issued by the Department; and
- [2] 4. In a manner which ensures that any mammal caught in the trap, snare or similar device is removed from the trap, snare or similar device.

NOTICE OF INTENT TO ACT UPON A REGULATION Notice of Hearing for the (Adoption/Amendment/Repeal) of Regulations of the Nevada Board of Wildlife Commissioners

The Board of Wildlife Commissioners will hold a public hearing on <u>TBA</u>. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of Commission General Regulation 450 (LCB File No. R087-14) pertaining to Chapter 503 of the Nevada Administrative Code.

1) The need for and purpose of the proposed regulation:

User group concerns voiced at the 2013 Legislative Session resulted in Senate Bill 213, NRS 503.570, which directs the Nevada Board of Wildlife Commissioners (NBWC) to adopt regulations setting forth the frequency at which a person who takes wild animals by means of traps, snares or similar device must visit or cause to be visited each device. The regulations must require the person to visit a device at least once each 96 hours. It further directs the NBWC to consider requiring a trap, snare or similar device placed in close proximity to a populated or heavily used area by persons to be visited more frequently than a device which is not placed in close proximity to such an area.

2) Text of the proposed regulation:

Will this regulation likely impose a direct and significant economic burden upon small business?

There are no economic impacts on businesses or groups. This regulation affects individual sportsmen who participate in trapping.

4) Will this regulation directly restrict formation, operation or expansion of small business?

This regulation does not restrict the formation, operation or expansion of small business.

5) Describe how the concerted effort was made to determine the business impact:

This regulation does not impact small business.

 - (i) Adverse effect This regulation does not regulate businesses.

 - (i) Adverse effect This regulation will regulate sportsmen who elect to trap in the designated calendar day visitation areas. They will be required to visit those traps more frequently than under current regulation. These sportsmen may have to incur additional costs to meet visitation requirements in those areas.
 - (ii) Beneficial effect Sportsmen affected by this proposed regulation have not voiced any beneficial economic effects to their commercial or recreational endeavors.

 - The proposed changes in this regulation only impact individual trapping sportsmen and do not impact small business; therefore it was not necessary to calculate the financial impact.

- 9) Estimated cost to the Department of Wildlife for enforcement of the proposed regulation:

Game wardens are already enforcing trap visitation regulations. There should not be any additional costs incurred or cost savings realized.

Small Business Impact Statement

Commission General Regulation 450 LCB File No. R087-14

Trap Visitation

Senate Bill 213, NRS 503.570, directs the Nevada Board of Wildlife Commissioners (NBWC) to adopt regulations setting forth the frequency at which a person who takes or causes to be taken wild animals by means of traps, snares or similar devices which do not, or are not designed to, cause immediate death to the mammals, must visit a trap, snare or similar device. The regulations must require the person to visit a trap, snare or similar device at least once each 96 hours. It further directs the NBWC to consider requiring a trap, snare or similar device placed in close proximity to a populated or heavily used area by persons to be visited more frequently than a trap, snare or similar device which is not placed in close proximity to such an area.

This proposed regulation impacts individual sportsmen and does not impact small businesses. Although licensed trappers can organize into special interest groups, they are licensed as individual sportsmen and are not bound by any laws that regulate small businesses.

Sportsmen that participate in trapping can do so as a recreational pursuit, a commercial venture or a combination of both. Although there is a commercial component to trapping, licensing is done on an individual basis and individuals are not required to be licensed or permitted as a business entity.

NDOW concludes that this proposed regulation does not impose any direct and significant economic burden upon nor does it restrict the formation, operation or expansion of a small business.
