PROPOSED REGULATION OF THE BOARD OF WILDLIFE COMMISSIONERS

COMMISSION GENERAL REGULATION 439

EXPLANATION – Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted

AUTHORITY: §§1, NRS 501.105, 501.181 and 503.150

A REGULATION relating to define what can be towed behind a vessel in a prohibited or restricted areas closed to water skiing for public safety in high use areas, narrow channels or certain bodies are not large enough to accommodate that type of activity.

NAC 488.450 Waterskiing and similar activities. (NRS 488.045, 488.059, 501.181, 501.243)

- 1. Towing a person or persons on water skies, a surfboard, an inflatable device or any similar device is authorized on: [Waterskiing is authorized on]
 - (a) The Eagle Valley Reservoir between the hours of 10 a.m. and 3 p.m.
- (b) Comins Lake between 11 a.m. and sunset. A vessel may not be operated at a speed in excess of 5 nautical miles per hour during other hours. The speed of a vessel underway is considered to be 5 nautical miles per hour or less if the vessel is not leaving a wake.
- 2. Towing a person or persons on water skies, a surfboard, an inflatable device or any similar device is prohibited in the following waters: [Waterskiing is prohibited on the following waters]

- 3. A person being towed on skis, an inflatable device or any similar device shall wear a personal flotation device which is approved by the United States Coast Guard.
- 4. A person shall not operate a vessel on any waters of this State towing a person or persons on water skis, a surfboard, an inflatable device or any similar device if the manufacturer's recommended safe loading capacity for the vessel would be exceeded if the person or persons being towed had to board the vessel as a passenger.

Notice of Hearing for the (Adoption/Amendment/Repeal) of Regulations of the Nevada Board of Wildlife Commissioners

The Board of Wildlife Commissioners will hold a public hearing on <u>TBA</u>. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulation Commission General Regulation 439 (LCB File No. R108-14) pertaining to Chapter 488 of the Nevada Administrative Code.

1) The need for and purpose of the proposed regulation:

Under NRS 488 we have specific areas closed to water skiing. These areas are closed for public safety purposes such as high use areas in narrow channels or certain bodies of waters are not large enough to accommodate those types of activities. We now are encountering other types of tow devices coming into these areas but the regulation is not specific to those activities. The change would cover all apparatuses towed by a vessel making these areas safer.

2) Text of the proposed regulation:

There is none. The activity is to better defining tow apparatuses.
