Firearm Carry During Archery or Muzzleloader Only Seasons

The Board of Wildlife Commissioners will hold a public workshop on August 7, 2015 at 1:30 p.m., at the Churchill County Chambers, 155 N. Taylor Street, Fallon, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the adoption of regulation Commission General Regulation 454 (LCB File No. R007-15) pertaining to Chapter 503 of the Nevada Administrative Code.

- 1) The need for and purpose of the proposed regulation: (Description of regulation)
 The proposed regulation was at the request of the Nevada sportsmen to explore a change allowing personal protection firearm carry in the field while hunting under archery or muzzleloader regulations. Some sportsmen have voiced concern that their personal safety was at risk when archery or muzzleloader hunting because firearm carry was prohibited while hunting under archery or muzzleloader regulations.
- 2) Text of the proposed regulation: See attached regulation.
- 3) Will this regulation likely impose a direct and significant economic burden upon small business?
 - No, this regulation will not likely impose a direct and significant economic burden upon a small business because this regulation does not regulate businesses.
- 4) Will this regulation directly restrict formation, operation or expansion of small business? No, this regulation will not directly restrict formation, operation or expansion of a small business because this regulation does not regulate businesses.
- 5) Describe how the concerted effort was made to determine the business impact: The Nevada Department of Wildlife determined there would be no business impact because the regulation proposed regulates individual hunters and not businesses.

- (i) Adverse effect The regulation will not have any adverse economic effect on a business because this regulation does not regulate businesses.

 - (i) Adverse effect This regulation does not have an adverse economic effect on the public. This regulation allows for individual archery or muzzleloader hunters to carry a non-hunting approved handgun while archery or muzzleloader hunting.
 - (ii) Beneficial effect This regulation does not have a beneficial economic effect on the public. This regulation allows for individual archery or muzzleloader hunters to carry a non-hunting approved handgun while archery or muzzleloader hunting.
- 7) Describe the method used to calculate the financial impact (positive, negative, or none) on small businesses:
 There were no methods used to calculate the financial impact on small businesses. It was determined there would be no business impact because the regulation proposed regulates individual hunters and not businesses.

 Chief Game Warden Tyler Turnipseed
- 9) Estimated cost to the Department of Wildlife for enforcement of the proposed regulation: There will be no costs to enforce this regulation. Game wardens are already enforcing this regulation.

Written submissions must be received by the Secretary, Board of Wildlife Commissioners, at least five days before the scheduled public hearing. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the Board of Wildlife Commissioners may proceed immediately to act upon any written submissions.

Copies will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

Upon adoption of any regulation, the agency, if requested to do so by an interested person either before adoption or within 30 days thereafter, shall issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.

It is our belief that a concerted effort has been made by NDOW to determine the impact of the proposed regulation on small businesses and the information contained in this statement is accurate.

Small Business Impact Statement

Commission General Regulation 454 LCB File No. T005-14/R007-15 Firearm Carry During Archery and Muzzleloader Only Seasons

The Commission will consider permanent adoption of the temporary regulation which expires November 1, 2015, relating to the carry of a firearm in the field while hunting under archery and muzzleloader regulations, including language changes from AB 136 of the 78th Legislative Session. The regulation will change NAC's 503.142 and 503.144 to allow the carry of personal protection handguns while archery and muzzleloader hunting. The Nevada Board of Wildlife Commissioners (NBWC) will hold a workshop at their meeting on August 7, 2015, and for possible action at their September 25-26, 2015 meeting.

The proposed regulation was at the request of the Nevada sportsmen to explore a change allowing personal protection firearm carry in the field while hunting under archery regulations. Some sportsmen have voiced concern that their personal safety was at risk when archery hunting because firearm carry was prohibited while hunting under archery regulations.

Although sportsmen can organize into special interest groups, they are licensed as individual sportsmen and are not bound by any laws that regulate small businesses. The proposed changes to the regulation only apply to individuals who are hunting during archery only season. This will allow them to carry a sidearm in the field while hunting under archery regulations. Therefore, Nevada Department of Wildlife (NDOW) has determined there will be no impact, either positive or negative to small businesses.

Because there are no businesses directly associated with handgun carry during archery season, Chief Game Warden Tyler Turnipseed concluded that this proposed regulation does not impose an economic burden upon, nor restrict the formation, operation, or expansion of any small business.

NDOW presented this regulation to the NBWC at their meeting with a workshop held on November 14, 2014, and the adoption hearing held on February 7, 2015, and solicited comments from the public to explain the proposed regulation change. This allowed for the regulation change to be heard by all of the County Advisory Boards to Manage Wildlife at their meetings prior to the workshop and adoption hearings. These meetings were open to the public. Businesses, sportsmen, and individual members of the public could provide comment on the proposed regulation at these meetings. There was no opposition voiced at these meetings regarding an economic impact.

There will be no additional cost to NDOW for the enactment or enforcement of this regulation.

The proposed regulation does not include provisions that will be duplicative of or more stringent than federal, state, or local standards and do not provide a new fee or increase in an existing fee.
