The purpose of this Hearing is to receive comments from all interested persons regarding the adoption of amendments that pertain to 483 & 426 of the Nevada Administrate Code. These regulations are being proposed pursuant to:

NRS 483.908 (5) requires the Department of Motor Vehicles to adopt regulations necessary to carry out the provisions of NRS 483.900 to 483.940, inclusive.

NRS 426.441 (4) (c) permits the Department of Motor Vehicles to adopt regulations that are necessary to charge fees for expedited services permits.

Note: Items on the agenda may be taken in a different order than listed. Two or more agenda items

may be combined for consideration. An item may be removed from this agenda or discussion relating to an item on this agenda may be delayed at any time.

A period of public comment will be allowed after each item on the agenda. No action will be taken on these items during the public hearing. Because of time considerations, the period for public comment by each speaker may be limited.

ITEMS FOR CONSIDERATION

- Department will issue a Commercial Learner Permit (CLP)
- A CLP is valid for 180 days from issuance
- A CLP must be held for 14 days prior to testing
- Must hold a base license to be issued a CLP
- Must be issued a CLP prior to the issuance of a commercial driver license
- Every second renewal of a CLP requires all knowledge testing
- Skills testing may not be banked when renewing a CLP
- Third Party Certifiers must perform 10 skills tests each calendar year
- Third Party Certifiers must have a background check
- Third Party testers are required to maintain a bond
- Firefighters and other emergency responders are not required to have a particular class of license just endorsement to operate emergency vehicles
- Updates to acceptable documents for proof of identity

If you cannot attend the hearing, written comments may be submitted to the Department of Motor Vehicles.
