### ADOPTED REGULATION OF THE

## STATE SEALER OF CONSUMER EQUITABILITY

#### LCB File No. R096-15

Effective December 21, 2015

EXPLANATION - Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted.

AUTHORITY: §1, NRS 581.050, 581.067, as amended by section 136 of Assembly Bill No. 77, chapter 526, Statutes of Nevada 2015, at page 3620, and NRS 581.075.

A REGULATION relating to measuring devices; requiring a fee to be charged for the retesting of certain cash registers and point-of-sale systems; setting the amount of the fee; revising the amount of the fee for certification of standards used in testing; and providing other matters properly relating thereto.

## **Legislative Counsel's Digest:**

Existing law authorizes the State Sealer of Consumer Equitability to conduct random tests of cash registers and point-of-sale systems to ensure compliance with certain standards. (NRS 581.067, as amended by section 136 of Assembly Bill No. 77, chapter 526, Statutes of Nevada 2015, at page 3620) Existing law also authorizes the State Sealer to establish necessary fees for testing. (NRS 581.075) Existing regulations establish fees for certain tests conducted by the State Sealer. (NAC 581.210) This regulation adds fees for the retesting of cash registers and point-of-sale systems which are found to be out of compliance with standards during a random test. This regulation also revises the fees for the certification of standards used in testing.

- **Section 1.** NAC 581.210 is hereby amended to read as follows:
- 581.210 1. The tests and services for which fees will be charged pursuant to this section include, without limitation:
  - (a) A retest of [a]:
    - (1) A device which was marked "out of order" during a test [...; or

- (2) A point-of-sale system or cash register found to not be in compliance during a test conducted pursuant to subsection 19 of NRS 581.067, as amended by section 136 of Assembly Bill No. 77, chapter 526, Statutes of Nevada 2015, at page 3620.
- (b) A trip to test a device which was not available or ready for testing at the time scheduled for a test.
- (c) A test requested for a device if a special trip is required to perform the test. If, upon the arrival of the inspector, the test scheduled for the device cannot be performed for any reason which is not the fault of the Division or the inspector, any fee which would have been charged for that test remains due.
  - (d) A test requested for a noncommercial device.
  - (e) A calibration according to industrial standards of weights and measures.
- (f) An adjustment of a commercial device immediately following a determination of noncompliance during an annual test.

# LEGISLATIVE REVIEW OF ADOPTED REGULATIONS- NRS 581.050,581.067 Informational Statement LCB File No. R096-15

1. A clear and concise explanation of the need for the adopted regulation.

The need to adopt changes to NAC 581.210 is twofold. First, AB 77 directs CE to check point-of sales devices as well as cash registers for accuracy but does not provide a licensing fee for these devices. This fee request will help cover the cost of the program as well as the cost to the State for rechecking devices that are non-compliant. Second, the fees the department has been charging for metrology work does not begin to cover the costs of the program. The Metrologist position ranges from a paygrade 32-36 and the cost of upgrading aging equipment has been in excess of \$60,000.

The estimated economic effect on the business these fees regulate is minimal. The fee only applies to point-of -sales and cash registers that are out of

compliance. The fee increase associated with metrology work will bring Nevada in line with fees charged by other states.

11. If the regulation provides a new fee or increases an existing fee, the total annual amount the agency expects to collect and the manner in which the money will be used.

Current fees for metrology work in the state of Nevada range from \$40 to \$80/Hour. Currently there are no fees associated with point-of sales or cash registers found out of compliance

Fee Increase Proposal: The proposal will increase metrology fees to between \$75 and \$95/ Hour. Fees for non-compliant cash registers and point-of sales devices will be \$50 or \$125 depending on total number of cash registers and point-of-sales devices.

Estimated additional revenue will be hard to determine for point-of sales devices and cash registers as this is a new program and we have no data available to estimate revenue. Additionally fees can only be charged for out of compliance devices.

Estimated additional revenue for metrology will approximately \$10,000- \$15,000 based on historical data.

The money from the metrology fee increase will be used to help offset the salaries of the Meteorologists as well as updating and maintaining equipment.

Nevada's metrology fees remain among the lowest fee of all surrounding states. The fees will increase the cost to businesses, but if Nevada cannot sustain its Metrology Lab then cost to industry will increase even more due to higher fees charged by other states as well as transportation costs.
