The purpose of the hearing is to receive comments from all interested persons concerning the proposed regulation regarding the Commission's authority to modify resource plans submitted by certain public utilities. A period will be provided for comments by the general public and discussion of those comments. If no person who is directly affected by the proposed regulation appears at the hearing to request time to make an oral presentation, the Commission may proceed to act upon any written submissions.

The following information is provided pursuant to the requirements of NRS 233B.0603:

The proposed regulation is required pursuant to SB 87 to define the process for modifying resource plans submitted by certain public utilities.

The proposed regulation may have potential immediate and long-term adverse effects on utilities, but these effects stem from the authorizing statute, SB 87, and not from the proposed regulation. Specifically, the proposed regulation allowing the Commission to modify the action plans and amendments to the action plans of certain utilities may require the utilities to expend additional resources to evaluate and gain approval of action plans in the future.

The proposed regulation allows the Commission to modify utilities' action plans, which may have a beneficial effect to the public if the regulation results in improved action plans with reduced costs. However, the regulation produces neither immediate nor long-term beneficial effects on the utilities affected by the regulation.

The Commission used the simplified Delphi method in determining the impact on small businesses, whereby experts review the text of the proposed regulations and determine the likely impact of the proposed regulation on small businesses. These experts share their responses with each other and form a consensus view. The Commission found that the proposed regulation is not likely to impose a direct or significant economic burden upon small businesses, and is not likely to directly restrict the formation, operation, or expansion of a small business.

There will be no additional cost to the Commission for the enforcement of the proposed regulation.

The proposed regulation does not overlap or duplicate any federal, state, or local regulation.

The proposed regulation is not required pursuant to federal law.

The proposed regulation is not more stringent than a federal regulation that regulates the same activity.

The proposed regulation does not establish any new fee or increase an existing fee.

This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations (LCB File No. R110-15), which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653 and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. This does not apply to a public body subject to the Open Meeting Law.

Upon adoption of any regulation, the Commission, if requested to do so by an interested

person, either before adoption or within thirty (30) days thereafter, will issue a concise statement

of the principal reasons for and against its adoption or incorporate therein its reason for

overruling the consideration urged against its adoption.

Pursuant to NRS 233B.060(1), the Presiding Officer in this matter anticipates placing the

proposed regulation on a Commission Agenda no earlier than March 30, 2016, for the

Commission's consideration as to whether to adopt the regulation as permanent.
