

# PROPOSED REGULATION OF THE DEPARTMENT OF EDUCATION

## LCB File No. R136-15

### Suggested Regulatory Language – Moral Turpitude

*For the purposes of Title 34 of the Nevada Revised Statutes, including NRS 391.033, NRS 391.100, NRS 391.31297, NRS 391.314, NRS 391.330, NRS 392A.080, and NRS 392A.107, crimes or offenses involving moral turpitude shall include any and all of the following crimes and offenses, as well as attempt, conspiracy or solicitation to commit any of the following crimes, or any crimes, offenses, or violations of law in other states, countries or municipalities with substantially similar factual requirements:*

- *Any offense of a sexual nature, specifically including any offense prohibited by NRS 200.364-NRS 200.3784 inclusive, NRS 200.463-NRS 200.469 inclusive, NRS 200.700-NRS 200.760 inclusive, NRS 201.160-NRS 201.195 inclusive, NRS 201.210-NRS 201.230 inclusive, NRS 201.235-NRS 201.254 inclusive, NRS 201.256-NRS 201.2655 inclusive, NRS 201.295-NRS 201.440 inclusive, NRS 201.450, or NRS 201.470-NRS 201.560 inclusive.*
- *Any offense of a violent nature, specifically including any offense prohibited by NRS 200.010-NRS 200.450 inclusive or NRS 200.471-NRS 200.490 inclusive.*
- *Any offense of a violation of immigration laws specifically including any offense prohibited by 8 USC 1325 or NRS 200.463-NRS 200.469 inclusive.*
- *Any offense of unlawful possession or use of a firearm, explosive, or other prohibited weapon, specifically including any offense prohibited by NRS 202.257-NRS 202.440 inclusive, NRS 202.445-NRS 205.449 inclusive, or NRS 202.750-NRS 202.840 inclusive.*
- *Any offense of abuse, neglect or endangerment of a child, older person or vulnerable person, specifically including any offense prohibited by NRS 200.508-NRS 200.50995 inclusive, NRS 200.700-NRS 200.760 inclusive, NRS 201.090-NRS 201.110 inclusive, NRS 201.256-NRS 201.2655 inclusive, or NRS 201.470-NRS 201.560 inclusive.*
- *Any offense of arson, specifically including any offense prohibited by NRS 205.005-NRS 205.055 inclusive.*
- *Any offense of burglary, robbery or receipt of stolen property, specifically including any offense prohibited by NRS 200.380 or NRS 205.060-NRS 205.295 inclusive.*
- *Any offense of kidnapping or unlawful detention, specifically including any offense prohibited by NRS 200.310 or NRS 200.460.*
- *Any offense of aiding or harboring a fugitive, specifically including any offense prohibited by NRS 195.030 or NRS 199.100.*

- *Any offense of Identity theft, specifically including any offense prohibited by NRS 205.463.*
- *Any offense under color of authority, specifically including any offense prohibited by 42 USC 1983 or NRS 197.200.*
- *Any offense of bribery or coercion, specifically including any offense prohibited by NRS 197.010-NRS 197.110 inclusive, NRS 201.570, NRS 202.4415, or NRS 207.190.*
- *Any offense of the manufacturing, cultivation or distribution of a controlled substance, specifically including any offense prohibited by NRS 453.316-NRS 453.348 inclusive.*
- *Any offense of DUI or DWI, specifically including any offense prohibited by NRS 484C.010-NRS 484C.640 inclusive.*
- *Any offense of animal cruelty, specifically including any offense prohibited by NRS 574.100- NRS 574.120 inclusive.*
- *Petit larceny, specifically including any offense prohibited by NRS 205.240.*
- *Shoplifting, specifically including any offense prohibited by NRS 205.0832 or NRS 597.850-597.870 inclusive.*
- *Possession of a controlled substance, specifically including any offense prohibited by NRS 453.336.*
- *Contributing to the delinquency of a minor, specifically including any offense prohibited by NRS 201.090-NRS 201.110 inclusive.*
- *Fraud, specifically including any offense prohibited by NRS 205.330-205.460 inclusive.*
- *Embezzlement, specifically including any offense prohibited by NRS 205.300-NRS 205.312 inclusive.*
- *Forgery, specifically including any offense prohibited by NRS 205.085-NRS 205.217 inclusive.*
- *Larceny, specifically including any offense prohibited by NRS 205.220-NRS 205.230 inclusive.*
- *Theft, specifically including any offense prohibited by NRS 205.0821-205.835 inclusive.*

*For the purposes of NRS 391.033, any conviction of a felony, misdemeanor, or gross misdemeanor for any of the following is deemed related to all positions with the county school districts or charter schools for which licensure is required and thus is a lifetime disqualification for licensure:*

- *Any offense of a sexual nature*
- *Any offense of a violent nature*
- *Any offense of a violation of immigration laws*
- *Any offense of unlawful possession or use of a firearm*
- *Any offense of abuse, neglect or endangerment of a child*

- *Any offense of arson*
- *Any offense of burglary, robbery or receipt of stolen property*
- *Any offense of kidnapping or unlawful detention*
- *Any offense of harboring a fugitive*
- *Any offense of identity theft*
- *Any offense under color of authority*
- *Any offense of bribery or coercion*
- *Any offense of the manufacturing, cultivation or distribution of a controlled substance*
- *Any offense of animal cruelty*

*For the purposes of NRS 391.033, any conviction of a felony, misdemeanor, or gross misdemeanor for the following are deemed to be related to all positions with the county school districts or charter schools for which licensure is required for a period of 10 years and thus is a 10 year disqualification for licensure from the date of conviction:*

- *Possession of a controlled substance*
- *Contributing to the delinquency of a minor*
- *Fraud*
- *Embezzlement*
- *Forgery*
- *Larceny*
- *Theft*
- *Multiple (2 or more) convictions for DUI or DWI*

*For the purposes of NRS 391.033, any conviction of a felony, misdemeanor, or gross misdemeanor for the following are deemed to be related to all positions with the county school districts or charter schools for which licensure is required for a period of 5 years and thus is a 5 year disqualification of licensure from date of conviction:*

- *DUI or DWI (single conviction)*
- *Petit larceny*
- *Shoplifting*
