

LEGISLATIVE REVIEW OF ADOPTED REGULATIONS—NRS 233B.066

Informational Statement

1. A clear and concise explanation of the need for the adopted regulation:

To define “moral” turpitude” for the purpose of implementing NRS 391.033, which relates to the licensure of educators in the State of Nevada. While NRS 391.033 lists a conviction for “any offense involving moral turpitude” as grounds for the denial of an application for an educator license, “moral turpitude” is not defined within either NRS or NAC.
