The State of Nevada, Department of Business and Industry, Division of Insurance ("Division"), (775) 687-0700, previously provided notice regarding a public hearing scheduled to take place at 9:30 a.m. on November 9, 2017, at the Division's offices in Carson City and Las Vegas. The intended purpose of the hearing was to receive comments from all interested persons regarding the adoption, amendment or repeal of regulations pertaining to chapter 683A of the Nevada Administrative Code ("NAC"), concerning:

LCB File No. R087-17. Third Party Administrator Parental Guaranty and Notification Requirements. A regulation relating to insurance; requiring certain applicants for a certificate of registration as an administrator to submit certain financial statements; authorizing certain applicants for a certificate of registration as an administrator to submit the financial statement of the parent company of such an applicant; requiring the financial statements submitted by an applicant for a certificate of registration as an administrator to contain certain information; requiring an administrator to notify the Commissioner of Insurance of certain changes not later than 30 days after the change occurred; and providing other matters properly relating thereto.

Based upon comments received at the public workshop held in this matter on October 25, 2017, the Division has proposed revisions to the regulation which require additional review and drafting by the Legislative Counsel Bureau ("LCB"). The new hearing date will be set and properly noticed again pursuant to chapter 233B of NRS.
