LEGISLATIVE REVIEW OF ADOPTED REGULATIONS--NRS 233B.066 Informational Statement LCB File No. R022-18

1. A clear and concise explanation of the need for the adopted regulation.

The regulation implements Senate Bill 145 (2017) by amending Chapter 701B of the Nevada Administrative Code ("NAC") to expand regulations incentivizing energy storage systems as part of the Solar Energy Systems Incentive Program, creating the Electric Vehicle Infrastructure Demonstration Program, and allocating funds for the installation of solar energy systems and distributed energy generation systems benefiting low-income customers.

Comments were solicited from affected businesses in the same manner as they were solicited from the public. The summary may be obtained as instructed in the response to question 2(c).

Several participants suggested clarifying changes to the regulation. Based on comments submitted and discussion in prior workshops, no clarifications were made, however, two typographical errors were corrected and a section that was inadvertently left out by the Legislative Counsel Bureau was added back in.

The regulation does not impose any adverse economic effect on the business it is intended to regulate. It does require NV Energy to continue acting as the administrator of the already-existing renewable programs under NRS Chapter 701B in addition to the programs created by SB 145 (2017).

(b) Estimated economic effect on the public which they are to regulate.

The regulation does not regulate the public.

12. If the proposed regulation is likely to impose a direct and significant burden upon a small business or directly restrict the formation, operation or expansion of a small business, what methods did the agency use in determining the impact of the regulation on a small business?

Staff conducted a Delphi Method exercise to determine the impact of this proposed regulation on small businesses. The Delphi Method is a systematic, interactive, forecasting method based on independent inputs of selected experts. In this instance, the participants were members of Staff. Each participant in the exercise used his background and expertise to reflect upon and analyze the impact of the proposed regulation on small businesses. Based upon Staff's analysis, Staff recommended to the Commission that the Commission find that the proposed regulation will not impose a direct and significant economic burden

on small businesses or directly restrict the formation, operation or expansion of a small business. The Commission accepted Staff's recommendation and found that the proposed regulation does not impose a direct or significant economic burden upon small businesses, nor does it directly restrict the formation, operation, or expansion of a small business, and therefore a small business impact statement pursuant to NRS 233B.0608(2) is not required. This finding was memorialized in an Order issued in Docket No. 17-08021 on February 27, 2018.
