Notice of Hearing for the Adoption, Amendment and

Repeal of Regulations of the

The Board for Administration of the Subsequent Injury Account for

Associations of Self-Insured Public or Private Employers

The Board for the Administration of the Subsequent Injury Account for Associations of Self-Insured Public or Private Employers will hold a public hearing at 10:00 a.m., on the 11th day of December, 2018, at the Division of Industrial Relations, Department of Business and Industry, 3360 W. Sahara Avenue, Suite 250, Executive Video Conference Room, Las Vegas, NV 89102. The purpose of the hearing is to receive comments from all interested persons regarding the Adoption, Amendment and Repeal of Regulations that pertain to Chapter 616B.773 *et. seq.*, of the Nevada Administrative Code, a copy of which is attached hereto.

On August 16, 2018, the Board held a meeting pursuant to a "Notice of Intent" and approved revisions to the existing Regulations. The purpose of the meeting held pursuant to this Notice of Intent is to adopt one further revision or correction in the Regulations by deleting Section 16, paragraph 5, at page 17, of the previously approved amended Regulations. The reason for the deletion is to further streamline and simply the application process for reimbursement from the Account the Board administers. The entire proposed Regulations are attached with the deletion of Section 16, paragraph 5 incorporated therein. The deletion of Section 16, paragraph 5 is the only change made the subject of this Notice of Intent.

The following information is provided pursuant to the requirements of NRS 223B.0603:

1. The need for and purpose of the proposed regulations and amendments:

- (a) Implementation of changes enacted by the Legislature since 2007 to the present:
- (b) NRS 233B.050(1)(a) which requires the Board to enact rules of practice;
- (c) NRS 616B.575(6) and 616B.578(6), which authorize the Board to adopt regulations governing the administration and practice before the Board;
- (d) NRS 233B.120 which requires Boards to adopt regulations which provide for the filing and disposition of petitions for declaratory orders and advisory opinions;
- (e) NRS 233B.050(1)(d) and (e) which require periodic review of the Board's regulations;
- (f) The Board's determination that the process for deciding applications for reimbursement could be further standardized and streamlined through regulations reflecting upon the Board's experience deciding claims since the Board's inception; and
- (g) Decisions of the Nevada Supreme Court directly impacting the Board.

2. Either the terms or substance of the regulations to be adopted, amended or repealed, or a description of the subjects and issues involved. The subjects and issues involved are:

- (a) Provisions for the parties to request the amendment or repeal of the Board's regulations;
- (b) Provisions for declaratory and injunctive relief;
- (c) Standards for allowing annuities to be liquidated by the Account;
- (d) Provisions for seeking continuances or extensions of time to respond to the Board;
- (e) Standards for the commutation of payments from the Account;
- (f) General Procedures for submitting claims;
- (g) Identification of methods for filing and service of process and pleadings;
- (h) Standards for assessing proof by written record of knowledge about preexisting conditions;
- (i) Clarification of processes in light of *Holiday Ret. Corp. v. State Div. of Indus. Rels.*, 274 P.3d 759, 2012 Nev. LEXIS 33, 128 Nev. Adv.Rep. 13, 2012 WL 1136405 (Nev. 2012);
- (j) Standards for establishing written records;
- (k) Consolidation of hearing procedures to simplify process; and
- (l) Deletion of Section 16, paragraph 5, from the Regulation to streamline the application process.

3. The estimated economic effect of the changes proposed in the existing regulations on the business which the Board regulates and on the public:

The Board determined that these proposed amendments and changes to the existing regulations will have no adverse economic effect, either immediate or long-term on either the public or small businesses (*e.g.*, Associations, employers, and/or third party administrators). The Board concludes, further, that by streamlining and clarifying and making the process, therefore, more efficient, if there is any economic effect, it will be positive on the public or small businesses by simplifying and clarifying the process by which applications for reimbursement are heard and decided.

To determine whether these regulatory matters, the proposed changes and new regulations, are likely to have an impact on small businesses, the Board considered the purpose and scope of the proposed and potential regulations, their amendment and changes in conjunction with the existing regulations. Based upon this review, the Board determined that since these proposed regulations are intended to streamline and clarify the existing regulatory structure, they are unlikely to have any adverse affect on small businesses.

4. Estimated cost to the agency for enforcement of the proposed changes to the regulations:

The Board estimates that there will be no increase in costs to the Board.

5. A description of and citation to any regulations of other state or local governmental agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. There is no duplication or overlapping of the proposed changes to the existing regulations at either the local governmental level, the State level, or with the Federal government.
