As per NRS233B.066 and NRS233B.0609 Proposed permanent regulation: Informational Statement Concerning Adopted Permanent Regulation;

LCB File No. R082-18

In accordance with NRS233B.061 (2), the following changes to NAC 623A were presented at workshops on August 24 & November 30, 2017 and January 24, 2018 concerning R082-18 Changes to Fees, Substituting Executive Director in place of President of the Board or designated member for investigations:

a) Authority is granted by NRS623A.130 Duties of the Board and NRS623A.240 Fees:

To replace the President of the Board or designated member with the Executive Director to investigate disciplinary and other actions to provide that the full board of 5 members will sit during adjudication hearing. Fees listed in **NAC623A.170** to be in line with the fees stated in **NRS623A.240**.

**NAC623A.351** revises the required sections of the national exam as the titles of these sections have changed.

- (1) The adoption of this regulation to replace the President of the Board or a designated member with the Executive Director to review and investigate complaints is to provide the board with a 5 member panel to sit during adjudication. Otherwise, one member will recuse, therefor only 4 members will sit during adjudication.
- (2) The adoption of fee increases in NAC623A.170 will mirror the fees listed in NRS623A.240. The Nevada Specific Exam requires the new applicants to answer questions from NRS623A and NAC623A. As the fees are not the same, this has caused some confusion and has been questioned by new applicants.
- (3) Revising the titles of the national exam sections listed in NAC623A.351 bring this section up to date.
- b) Notices of the workshops were posted on the NSBLA website, sent via email to all licensees and posted at Libraries across Nevada. All interested parties were asked to participate in the workshops, email comments and/or mail comments to the State Board Office. - f) The board adopted the regulation without change as presented. The comments received from the licensees were positive to the regulations. As the fees are not increasing and the substitution of the Executive Director to the President of the Board or designated member was considered internal workings of the board. No written or emailed response from effective businesses. Workshop attendees stated that as this appeared to be a housekeeping matter there was no objection to the changes.
- g) The estimated economic effect of the regulation on business.
- 1) (a) The direct effects on the business in the future would not change as the fees will remain the same, and the use of the Executive Director to investigate disciplinary actions will save time and money for the board.

  - (d) Adverse effect on the public is not contemplated at this time, as fees do not increase driving up overhead and utilizing the Executive Director to investigate disciplinary actions may not have an economical component to the public.

- h) The estimated cost to the Board of Landscape Architecture to enforce the proposed regulation to allow the Executive Director to investigate disciplinary actions is calculated as a decrease in time, due to the reduction of scheduling meetings with the Board President or designated board member and discussing the complaint.

These fees are used to maintain the office, staff, day-to-day operations of the board and the prescribed quarterly meetings of the board. The fees in NAC623A are being increased to bring them in line with the fees listed in NRS623A. There has been confusion by those who apply for licensure in the State of Nevada, as the Nevada Specific Exam asks questions concerning parts of NRS623A and NAC623A.
