NOTICE OF INTENT TO ACT UPON A REGULATION

Notice of Hearing for the Amendment and Repeal of Regulations of the Nevada Department of Public State Fire Marshal Division

The Nevada Department of Public Safety State Fire Marshal Division (SFMD) will hold a public hearing at 10:00 a.m., on the 12th of February 2020, at 107 Jacobsen Way, Classroom C, Carson City, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the Amendment and Repeal of regulations that pertain to Chapter 477 of the Nevada Administrative Code.

The following information is provided pursuant to the requirement of NRS 233B.0603:

1. A REGULATION relating to fire protection; adopting and revising certain publications by reference; revising the requirements for certificates of registration and licenses issued by the State Fire Marshal; increasing the fees for certain certificates of registration and licenses and renewals of certificates of registration and licenses; revising various provisions relating to fire systems, portable fire extinguishers and fixed fire extinguishing systems, Type I exhaust systems, child care facilities, displays of fireworks and displays of flame effects; revising provisions relating to reports of deficiencies and displays of flame effects; revising provisions relating to reports of deficiencies and impairments identified during an inspection of a fire alarm system or automatic fire sprinkler system; revising the procedure used to report data for purposes of the National Fire Incident Reporting System; and providing other matters properly relating thereto.

The purpose of this change is to address the changing issues involved in the construction of buildings in the State of Nevada. This change will ensure that buildings in Nevada comply with national building and safety standards thus resulting in providing safer buildings for employees and entertainment purposes.

- 3. The estimated economic effects of this amendment and repeal will result in a slighlty higher cost to licensing. If this change is not accomplished, the State of Nevada's

regulations will conflict with most of the jurisdictions in the State which have already adopted a more current edition of the fire codes and standards.

- 4. SFMD does not estimate any additional costs to enforce the amendments.
- 5. The proposed regulations do not overlap or duplicate the regulations of other state or local governmental agencies.
- 6. Federal law does not require the proposed regulation.
- 7. The proposed regulations do include provisions, which are more stringent than federal, state, or local standards regulating the same activity.

Persons wishing to comment upon the proposed action of the State Fire Marshal Division may appear at the scheduled public hearing or may address their comments, date, views or arguments, in written form to the State Fire Marshal Division at 107 Jacobsen Way, Carson City, Nevada or by email to pmilton@dps.state.nv.us Written submissions must be reveived by the State Fire Marshal Division on or before 11 February, 2020. If no person who is directly affected by the proposed action appears to request time to make an oral presentation, the State Fire Marshal Division may proceed immediately to act upon any written submissions.

A copy of this notice and the regulation to be adopted will be on file at the State Library, 100 Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be adopted will be available at the State Fire Marshal Division, 107 Jacobsen Way, Carson City Nevada 89711 and in all counties in which an office of the agency is not maintained, at the main public library, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations (R189-07), which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us . Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary. Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
