### LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY

#### NRS 233B.066

#### **LCB FILE R132-18**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 477.

1. A clear and concise explanation of the need for the adopted regulation.

This regulation is necessary to update the regulations to comply with existing statutory requirements. Nevada Revised Statute (NRS sections 477.032 and 477.033 requires the State Fire Marshal to adopt regulations to license firms and for the certifications of individuals in certain fire protection related activities. The State Fire Marshal shall prescribe the form to be used for those to apply for a license or a certificate of registration per NRS 477.033(2).

2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Copies of the proposed regulations, notices of workshop and notices of intent to act upon the regulation were sent by U.S. mail and email to persons who were known to have an interest in the licensing and certification of the fire protection industry as well as any persons who had specifically requested such notice. A second workshop was held on August 22, 2018, and the minutes of that workshop are attached hereto and contain a summary of the discussions held regarding the proposed amendments. There was no public comment received.

A third workshop was held on December 21<sup>st</sup>, 2018 and the minutes of that workshop are attached hereto and contain a summary of the discussions held regarding the proposed amendments. There was one public comment received regarding labels on fire extinguishers, swapping of fire extinguishers and servicing and installing equipment and the approval of said equipment by the authorities having jurisdiction.

A fourth and final workshop was held on March 28, 2019 and the minutes of that workshop are attached hereto and contain a summary of the discussions held regarding the proposed amendments. There was one public comment received regarding a question about records retention.

Comments were solicited from affected businesses in the same manner as they were solicited from the public. The summary may be obtained as instructed in the response to question #2.

6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

The permanent regulation was adopted on February 12, 2020. There several changes made during the intent to adopt hearing concerning the Wildland Urban Interface Code, the change was to revert back to the original verbiage of the previously adopted NAC 477. No opposition to the change or regulation was offered.

  - (a) Both adverse and beneficial effects:

**Adverse effect:** No adverse effects are anticipated as no undue requirements or restrictions are proposed by the regulation. NO adverse effects to the general public is anticipated.

**Beneficial effect:** Inclusion of the International Existing Building Code as a referenced document will provide specific guidance to the remodeling and re-use of existing buildings throughout communities. This will benefit the general public with safer buildings.

(b) Both immediate and long-term effects:

**Immediate effect:** Contractors and business owners will utilize the International Existing Building Code immediately upon approval of this regulation. This will benefit the general public with faster and safer rehabilitated buildings.

**Long term effect:** Vacant or unused buildings will be more readily available for rehabilitation and occupation. This will benefit the general public with less vacant buildings throughout communities.

8. The estimated cost to the agency for enforcement of this regulation.

There is no additional cost to the agency for enforcement of this regulation

A description of any regulations of other state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary.
