## LEGISLATIVE REVIEW OF ADOPTED REGULATIONS - NAC 484D Informational Statement LCB File No. R157-18

#### 1. A clear and concise explanation of the need for the adopted regulation.

The proposed regulation is needed to improve the safety of highways, interstates, and roadways as over-dimensional vehicles travel throughout the State of Nevada. Furthermore, these amended regulations will advance the harmonization of regulations in the trucking industry with other western states as well as update the permit office information to reflect current business practices.

*Increased Safety:* This regulation requires route surveys for vehicles with the dimensions of 20-26'W x 18'H to determine the safety of the route, any obstructions, and a plan to mitigate any obstructions (NAC 484D.645). It also requires over-dimensional vehicles abide by specified day and time travel restrictions into and out of the Las Vegas area (NAC 484D.655). It further revises the requirements for pilot cars based on types of highways, certain days and certain hours of the day (NAC 484D.670).

Harmonization: These amendments to the regulation allow for the movement of 14 feet wide single-trip permits to be allowed on a 24/7 basis on interstate highways in Nevada (NAC 484D.625 & NAC 484D.655). It also introduces language allowing for permits to be displayed on a mobile device, versus a paper copy (NAC 484D.625). Both amendments achieve further harmonization with other western states.

Permit Office Operations Update: The proposed regulation updates the Over-Dimensional Vehicle Permits Office hours (NAC 484D.610); adds new language referencing the availability of an online permitting system (NAC 484D.610); and clarifies that the permit office offers a "deposit" to establish billing services, versus a "credit" (NAC 484D.615).

*Workshops, Public Hearing and Response Summary:* Two workshops were held in 2018 and a series of roundtable discussions were facilitated with key industry stakeholders to solicit input on the revisions for two years prior to the Public Hearing.

A Public Hearing was held in Carson City on February 11, 2019, at the Nevada Department of Transportation Headquarters Building located at 1263 South Stewart Street, with video conferencing to Las Vegas (District I Office), Reno (District II Office), and Elko (District III Office) to allow for public comment.

a) One comment was received prior to the close of the public comment period for the Public Hearing (February 8, 2019 at 5pm). This public comment was incorporated into the presentation at the Public Hearing on February 11, 2019. Mr. Rich Casci, Sierra Rental Transport (Sparks Nevada), requested the phrase "On a weekend" be struck from the proposed amendments to NAC 484D.670 in Section 3 (a) subsection 3 (III) "On a weekend" and in Section 6 of the proposed amended regulations NAC 484D.670 Section (b) subsection 4 (II) "On a weekend", due to the apparent redundancy with NAC 484D.655 subsection 2.

The Transportation Board approved the regulation as proposed with the amendment, which eliminated the redundancy.

b) On January 8, 2019, Kim Yaeger, the Nevada Trucking Association Director of Marketing and Public Relations, submitted an email with the following statement: "On behalf of Paul Delong [Board Member, Nevada Trucking Association], Paul Enos [CEO, Nevada Trucking Association], and Todd Anderson [Board Member, Nevada Trucking Association] we are happy with the revised regulations to NAC 484D. Thank you for your support. We look forward to working with you in the future."

# 5. A description of how comment was solicited from affected businesses; a summary of their response; and an explanation of how other interested persons may obtain a copy of the summary.

Comments were solicited from affected businesses in the same manner as they were solicited from the public. Item #2 summarizes how comments were solicited; includes the responses; and details how an interested person may obtain a copy of the summary. A reiterated summary of each is provided below:

- 1) Copies of the proposed regulation, notice of intent to act upon a regulation, and notice of workshop and Public Hearing were sent by U.S. mail and email to small businesses who were known to have an interest in the subjects of noticing or that specifically requested said noticing and information. These documents were made available on the Nevada Department of Transportation (NDOT) website (www.nevadadot.com), and were also posted in the following offices of the Nevada Department of Transportation (NDOT) and public noticing locations: NDOT Locations (Offices—Headquarters, Districts I, II, and III; NDOT Maintenance Stations: Tonopah, Ely and Winnemucca); the Grant Sawyer State Office Building; and the following Courthouses: Washoe County and Clark County.
- 2) Two positive comments were received prior to the close of the public comment period for the Public Hearing (see detailed information in #2 above.). Both public comments were received by email from members of the public, who are also staff to small businesses affected by this regulation. One comment requested redundant language to be struck from specified sections of the proposed regulations and the other comment noted support for the amended regulations.

- 6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

No changes were recommended to the regulations that were presented either at the workshops or at the public hearing.

### 7. The estimated economic effect of the regulation on the business which it is to regulate and on the public.

Businesses in the trucking industry currently ensure safe transport by surveying routes and hiring pilot cars, when necessary and appropriate. While there is a cost to conduct both activities, it is not a new cost introduced by this regulation. Rather, it is industry best practice. Therefore, these proposed amendments are to keep pace with industry standards and are not anticipated to increase costs.

While there is not an estimated amount for the economic effect, these amendments could be more cost effective and beneficial for the trucking industry subject to this regulation. The ability to harmonize regulations with other states, increase allowable travel time, provide permits on a mobile device, and know that there is an online permitting system available can reduce industry costs, with the goal of increasing potential profits.

There is no direct effect on the public.

8. The estimated cost to the agency for enforcement of the proposed regulation.

The only costs associated with enforcement will be the cost for staff time. Given that these amended regulations align with current business practices, it is not estimated to incur additional salary costs.

9. A description of any regulation of other State or governmental agencies which the regulation overlaps or duplicates and a statement explaining why the duplication or overlap is necessary. If the regulation overlaps or duplicates a federal regulation, the name of the regulating federal agency.

These regulations do not overlap or duplicate any other regulations of the State or any other governmental agency.

There are no federal regulations that govern the regulation of travel for the same activity.

There are no fees associated with this regulation.

12. If the proposed regulation is likely to impose a direct and significant burden upon a small business or directly restrict the formation, operation, or expansion of a small business, what methods did the agency use in determining the impact of the regulation on small businesses?

These regulations govern how to obtain a permit and conditions by which travel is authorized for over-dimensional vehicles. There is no impact to that would restrict the formation, operation or expansion of a small business.
