The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 503.

The need for this regulation is to clarify and simplify existing regulations for bait fish use in the Department's Western and Southern regions.

Public comment was solicited during two regulation workshops of the Nevada Board of Wildlife Commissioners (NBWC) September and November 2019 meetings and during the adoption hearing in November 2019.

- 5. A description of how comment was solicited from affected businesses, a summary of their response, and an explanation how other interested persons may obtain a copy of the summary: The Department has regular communication with the owner of The Reno Fly Shop who has expressed unwavering support for the regulation simplification. Additionally, the Department has participated in the Reno Fly Shop sponsored open forum discussions with their customers in which the regulation was discussed and well received. The Reno Fly Shop is the only business that is anticipated to be affected by the regulation.

There were explanatory and grammatical changes made to the regulation.

No adverse effects are anticipated on the public. Anglers will benefit from simpler regulations on areas regarding the use of legal bait fish. The regulation clarifies what constitutes as a legal bait fish and becomes consistent with the State of Arizona in regarding the Colorado River system.

#### (b) Both immediate and long-term effects on the public:

Benefits to the public will be immediate and continue long-term.

The enforcement of the regulation falls within current operations of the Department; therefore, there will be no additional costs to the agency above the current budget.

The regulation simplifies the current regulation and ensures the regulation is consistent with the regulations for adjacent states on bi-state, shared waters.
