LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233B.066

LCB FILE R105-19

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 640A.

1. A clear and concise explanation of the need for the adopted regulation.

The need for the proposed regulations is to protect the public health, safety and welfare by ensuring that only qualified and competent occupational therapists and occupational therapy assistants are licensed in the state.

The purpose of the adopted regulation is to provide clarity for the public, individuals and licensees through regulations. The proposed regulation requires a licensee to notify the Board when obtaining employment and to notify the Board when there is a change in employment status. The proposed regulation updates continuing education requirements to align with the biennial renewal cycle and makes conforming changes to the continuing education requirements for reinstatement of an expired license.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Copies of the proposed regulation, notice of workshop and notice of intent to act upon the regulation were sent by e-mail and U.S. mail to persons who were known to have an interest in occupational therapy as well as any persons who had specifically requested such notice. A Workshop was held to solicit comments on the proposed regulations on November 23, 2019. There were seven (7) individuals from the public in attendance at the workshop, eleven (11) written comments were received. Thereafter, on or about January 7, 2020 a Notice of Intent to Act Upon Regulations was issued.

A Public Hearing was held on February 8, 2020. There were no additional written comments received at the Public Hearing. There were eight (8) practitioners and (18) students of Occupational Therapy in attendance. One (1) individual asked for clarification on the regulation at the Public Hearing, but did not provide testimony in support or opposition to the regulation.

6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

The Board of Occupational Therapy adopted the regulation on **February 8, 2020** without change.

The Board previously revised the proposed regulation to eliminate sections requiring further research as a result of public comments received in response to the Notice of Workshop held on November 23, 2019 and prior to the Public Hearing. No additional changes were made as a result of the Public Hearing process.

The Board determined the regulation was appropriate and necessary and that undue burden is not placed upon licensees to report employment status to the Board. In addition, the continuing education provisions were made to conform with the biennial license period and will make tracking and reporting of continuing education consistent with the two-year license period.

- 7. The estimated economic effect of the adopted regulation on the businesses which it is to regulate and on the public. These must be stated separately, and each case must include:

There will be no significant adverse economic effect of these adopted regulations on the businesses which it is to regulate (occupational therapists and occupational therapy assistants) or the public. The adopted regulations will benefit the occupational therapy practitioners and the public by clarifying employment reporting requirements and continuing education requirements.

(b) Both immediate and long-term effects.

Immediate effect will be improved administration through clarification of existing law and regulatory requirements. Long-term effect will be clarity and consistency in regulation of occupational therapy practitioners in Nevada.

8. The estimated cost to the agency for enforcement of the adopted regulations.

There are no additional costs involved in the enforcement of these adopted regulations.

9. A description of any regulations of other state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the regulation overlaps or duplicates a federal regulation, the name of the regulating federal agency.

The Board of Occupational Therapy is not aware of any similar regulations of other state or government agencies that the adopted regulations overlap or duplicate.

The Board of Occupational Therapy is not aware of any similar federal regulations of the same activity in which the adopted regulations are more stringent.
