LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY

NRS 233B.066 Informational Statement LCB File No. R080-20

1. A clear and concise explanation of the need for the adopted regulation.

This regulation is necessary to:

- Update the addresses of Nevada Department of Agriculture offices in Sparks and Las Vegas.
- Update the title for the adopted standard specification for diesel fuel and conform some language due to the title change.
- Update the purchase prices (from ASTM, International) for a number of adopted standard specifications, including diesel fuel, biodiesel fuel blend stock, biodiesel blends (B6 to B20), methanol fuel blends, ethanol fuel blends, the chemical composition of gases, and spark-ignition engine fuel (gasoline and gasoline -oxygenate blends).
- Update the name of a table referenced in NAC 590.065.
- Establish allowed descriptors for each grade of gasoline and blends of gasoline and oxygenate.
- Establish a new section that adopts the most recent standards for viscosity grade classifications and the specifications for engine oil performance and engine service classification published by SAE International.
- Establish a new section that sets certain standards for diesel fuel labeled "premier," "premium," "super" or "supreme" on retail dispensers, including standard test methods from ASTM, International and NACE.

2. Description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Copies of the proposed regulations, notices of workshop and notices of intent to act upon the regulation were sent by email to persons who were known to have an interest in the subject of motor fuels and petroleum products, as well as any persons who had specifically requested such notice. These documents were also made available at the website of the Nevada Department of Agriculture (NDA) www.agri.nv.gov, at the website Nevada Public Notice Website www.notice.nv.gov and were provided to all county libraries in Nevada and posted at the following locations:

A workshop was held on October 14, 2020 and the recording and minutes of that meeting contain the complete details of the workshop discussion. There was only one comment from

the attendees. Mr. Joseph Sorena, Chevron Products Company, spoke in support of the new sections being established and that the updates represent best practices.

A public hearing for the adoption of the regulations was held as an agenda item during the Nevada Board of Agriculture meeting on December 9, 2020. There were no comments expressing concern with any of the proposed changes. Mr. Paul Anderson, Board of Agriculture Chair and Petroleum Industry representative (also, Pilot Thomas Logistics) asked for a clarification of Premium Diesel (R080-20 Section 3 Subsection 3) and if diesel fuel marketed as "Top Tier" falls within the Premium Diesel definition. Mr. Peter Kruger, Nevada Petroleum Marketers and Convenience Store Association, inquired as to whether the proposed descriptors for gasoline grades considers the area of Nevada where 85 octane gasoline is commonly available. Mr. Kreuger also asked for a clarification of the several terms ("premier", "premium", "super", "supreme") associated with Premium Diesel.

5. A description of how comment was solicited from affected businesses, a summary of their response and an explanation of how other interested persons may obtain a copy of the summary.

A survey was conducted of small businesses that would potentially be affected by the regulation. The survey was available for completion online or in hard copy form. Notice of the survey was mailed via the United States Postal Service to 432 motor fuel and petroleum products stakeholders, requesting that those businesses meeting the definition of small business under NRS 233B.0382 complete the survey. The survey was open for response from August 6, 2020 through September 4, 2020. A total of 14 survey responses were received.

6. If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

Comments received at both the workshop on October 14, 2020 and the hearing on December 9, 2020 were supportive of the proposed actions and no changes were requested. As a result, the file was adopted as drafted.

- 7. The estimated economic effect of the regulation on the business which it is to regulate and on the public.
 - (a) Estimated economic effect on the businesses which they are to regulate.
 - (b) Estimated economic effect on the public.

Economic effect on business

a) Both adverse and beneficial effects

Adverse: Retailers who have been using incorrect descriptors for gasoline grades on their dispensers will incur a one-time cost for replacement labels with the approved descriptors.

The proposed regulation also includes updating the costs to purchase certain standards and specifications purchased by organizations other than the agency but adopted by the agency within NAC Chapter 590. Businesses who wish to purchase these documents will be subject to these higher prices.

Beneficial: Tightening the allowed descriptors for gasoline will level the marketplace and be beneficial to retailers who were already using the correct terms.

b) Both immediate and long-term effects

Immediate: The proposed regulation would go into effect when adoption of the regulation. Replacement labels (as described in 7(a) above) must be in place 90 days after adoption. No other costs are expected for businesses.

Long-term: There are not expected to be additional effects beyond that described above in Immediate Effects.

Economic effect on the public

a) Both adverse and beneficial effects

Adverse: The proposed regulation includes updating the costs to purchase certain standards and specifications purchased by organizations other than the agency but adopted by the agency within NAC Chapter 590. Members of the public who wish to purchase these documents will be subject to these higher prices.

Beneficial: The agency anticipates a benefit to the public through new sections being

added to NAC Chapter 590. The addition of language defining Premium Diesel will prevent consumers from purchasing, likely at a higher cost, a product that hasn't been vetted for quality claims made by the retailer. Codifying allowed descriptors for grades of gasoline will remove consumer confusion if faced by unfamiliar descriptors, or descriptors applied to a grade that are incorrect. Adoption of specifications for motor oil quality and compliance will protect the consumer from noncompliant product in the marketplace, preventing damage to their vehicles.

b) Both immediate and long-term effects

Immediate: Because nearly the whole of the regulation will be enacted immediately upon adoption by the Legislative Commission, public benefits will be immediate. Retailers will be allowed 90 days to replace any gasoline descriptor terms that don't conform to the regulation, so effects to the public will be less immediate, though not to be considered long-term.

Long-term: The agency believes that the effects on the public will be maintained on a long-term basis.

8. The estimated cost to the agency for enforcement of the proposed regulation:

The agency anticipates that its only cost to enforce the proposed revised provisions of NAC 590 will be to verify that a diesel fuel sold as premium diesel is, in fact, that product. At present, the agency does not have the analytical equipment necessary for that testing. The agency estimates that the testing will cost approximately \$1,000 per sample. At the present time, Premium Diesel has not been made available for sale to the public in Nevada.
