Informational Statement per NRS 233B.066

1. A clear and concise explanation of the need for the adopted regulation.

The need for the regulation is in detailing processes by which the Division of Public and Behavioral Health (DPBH) Administrator or their designee will approve and administer grants made pursuant to Nevada Revised Statutes (NRS) 422A.660 from the Diapering Resources Account of the DPBH.

2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

Public comment and feedback were solicited from the community and partners during a public workshop which was held on January 11, 2022. The only public comment that was offered during this workshop was from Kim Amato of Baby's Bounty and Assemblywoman Maggie Carlton of the United Labor Agency of Nevada and comments were positive and supportive of Division's efforts in relation to the diapering resources. No concerns were voiced at the public workshop. Information on the public workshop can be accessed at the following website:

Public comment and feedback were solicited at the public hearing of the State Board of Health, held on March 4, 2022. No public comment was given during this meeting for R086-20P.

A public workshop held on January 11, 2022, and nine (9) persons attended, including Division of Public and Behavioral Health staff. The names of the attendees are Kim Amato, Assemblywoman Maggie Carlton, Linda Anderson, Steve Messinger, Brian R. (no last name provided), Evelyn Dryer, Desiree Wenzel, Vickie Ives, and Karissa Loper. Verbal comments in support of the regulation were provided by Kim Amato, Founder, Baby's Bounty (kim@babysbounty.org) and Assemblywoman Maggie Carlton, Executive Director of the United Labor Agency of Nevada (services@ulan.org, 1201 N. Decatur Blvd., Ste. 106, Las Vegas, NV 89108, 702-648-3500).

A public hearing was held on March 4, 2022. At that hearing were 86 attendees. That number includes the members of the Board of Health, staff of the Division of Public and Behavioral Health, staff from other state agencies, as well as members of the public. As there were other items on the agenda, it is possible that not all those that signed in where in attendance for LCB File No R086-20P. No one testified in support of or against the proposed regulation or provided written statements during the hearing. Please see the attached document for the list of attendees.

4. A description of how comment was solicited (i.e., notices) from affected businesses, a summary of their response, and an explanation how other interested persons may obtain a copy of the summary.

Pursuant to NRS 233B.0608 (2) (a), The Division of Public and Behavioral solicited comments, as well as distributed draft copies of the regulation via email and the Bureau of Child, Family, and Community Wellness Diapering Resources Committee listsery to professional diapering resource agencies across the state.

A Small Business Impact Questionnaire was sent to professional diapering resource agencies statewide along with a copy of the proposed regulation changes, on September 28, 2021; a summary of responses is below.

Comments (Q#1): No comments.

Comments (Q#2):

- 1-Cost savings of \$12,000 to \$15,000 per year.
- 2- The Women and Children's Center of the Sierra (WACCS) has administered a diaper bank for the past 18 years. We distribute between 9,000 and 11,000 diapers monthly to women and single dads who live at 185% of poverty or less (the 185% of poverty mirrors Women Infants and Children requirements for services). We currently budget \$4,000 annually for diapers. We spend whatever we need to ensure an adequate supply of diapers given how many we receive in donations and through diaper drives. None of these are predictable.

Comments (Q#3): No comments.

Comments (Q#4):

- 1-Greater access to community resources thru case management.
- 2-WACCS has started working with the Food Bank of Northern Nevada so that we can accompany their Mobile Harvest food distribution program into impoverished communities where moms have a difficult time getting to our office. We believe that ideally, we can bring services to the people. This, of course, will greatly increase the number of diapers needed. Funding through the State program would help this expansion of services be successful.

R086-20P was adopted without any changes as a result of the respective public hearings because no negative comments nor suggested changes were received by the Division.

Anticipated effect on regulated businesses:

- a) Adverse effect: There is no anticipated adverse effect.
- b) Beneficial effect: This regulation creates a pathway and processes for the administration of grants to help underserved Nevadans access diapers and diapering supplies.
- c) Immediate effect: Entities wishing to provide diapers and diapering supplies in Nevada will be able to apply for grants from the Diapering Resources Account of the DPBH.
- d) Long-term effect: Entities wishing to provide diapers and diapering supplies in Nevada will be able to apply for grants from the Diapering Resources Account of the DPBH.

Anticipated effect on the public:

- a) Adverse effect: There is no anticipated adverse effect on the public.
- b) Beneficial effect: The public will have more access to diapers and diapering resources as there will be a process by which to administer grants from the Diapering Resources Account of the DPBH.
- c) Immediate effect: There is no anticipated immediate effect on the public until funds are brought into the account through successful grant procurement.
- d) Long-term effect: The public will have more access to diapers and diapering resources as there will be a process by which to administer grants from the Diapering Resources Account of the DPBH.

There is no cost to the agency for enforcement of the proposed regulation.
