## LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233B.066 LCB FILE R127-21

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 641.

#### 1. A clear and concise explanation of the need for the adopted regulation.

This regulation establishes continuing education requirements for psychologists, and requires they include at least 2 hours of instruction relating to cultural competency and diversity, equity and inclusion. The regulation was considered and adopted by the Board of Psychological Examiners in order to comply with the provisions enacted through Assembly Bill 327 (2021).

This regulation adds a list of subjects which are acceptable for a continuing education course or program in the area of cultural competency and diversity, equity and inclusion. In order to avoid confusion by psychological licensees when considering the types of continuing education required for licensure renewal, the language included in Assembly Bill 327 (2021) was copied exactly from the newly revised NRS 641.220.

# 2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Notice of a public workshop and notice of intent to act upon the regulation were sent to persons who were known to have interest in the application requirements of psychologists in the state of Nevada, as well as any specific person who requested notification regarding regulation changes. Such distribution included further information on how to receive a free copy of the proposed regulation. These documents were also made available through the website of the Board of Psychological Examiners, psyexam.nv.gov or by directly emailing the Board office (NBOP@govmail.state.nv.us), and posted at the locations listed below.

A workshop was held to discuss language changes to the current NAC 641 on September 10, 2021, and the minutes of the meeting, which can be obtained through contacting the Board office or locating them on the Board's website Psyexam.nv.gov, contain a summary of the discussion held regarding the proposed language change. No written or public comment was submitted.

Thereafter, on or about June 3, 2022, the Board of Psychological Examiners issued a Notice of Intent to Act Upon a Regulation which incorporated the proposed amendment

that was discussed at the above workshop. That notice included a request for submission of public comment regarding adoption of the regulation.

On July 8, 2022, a public hearing was held. No written public comment was received. Public testimony was heard from one individual but no changes were proposed. The Board of Psychological Examiners approved adoption of the proposed regulation R127-21 with no changes.

Comments were solicited from affected businesses in the same manner as they were solicited from the public. The request for input regarding impact was sent to all licensees of the Board of Psychological Examiners. The summary of the discussion by the Board may be obtained through the minutes; which can be obtained through contacting the Board office or locating them on the Board's website, psyexam.nv.gov. No written comment was submitted. While testimony from one individual was heard, no changes were proposed and the speaker was supportive of the change.
