## <u>LEGISLATIVE REVIEW OF ADOPTED REGULATIONS INFORMATIONAL</u> <u>STATEMENT AS REQUIRED BY NRS 233B.066</u>

## LCB FILE NO. R026-22

The following statement is submitted by the State of Nevada, Board of Oriental Medicine, for adopted amendments to Nevada Administrative Code ("NAC") Chapter 634A.

## (A) A clear and concise explanation of the need for the adopted regulation.

Response: The need for the proposed NAC 634A regulation is to update regulations regarding the applicants and the exams to better align with NRS 634A, streamline CEU approval process by accepting certain NCCAOM approved courses, eliminate certain inactive transfer fees, allow the acceptance of credit and debit cards, and eliminate regulations such as the English proficiency tests and the registration of practicing under a fictitious name which is already required by business licensing.

(B) A description of how public comment was solicited, a summary of the public response and an explanation of how other interested persons may obtain a copy of the summary. Response: On 3/3/2022, a small business impact survey was sent to all licensed Oriental Medicine Doctors and interested persons on the Board's email list to determine the impact of the proposed regulations.

Also, the Board of Oriental Medicine conducted a public workshop on 4/5/2022 via Zoom to solicit comments from small businesses. Notice of these workshops were posted at Nevada State Board of Oriental Medicine, Nevada State Board of Oriental Medicine website: <a href="http://orientalmedicine.nv.gov/">http://orientalmedicine.nv.gov/</a>, Office of the Attorney General (Carson City), Office of the Attorney General (Las Vegas), State Library and Archives, website @ Notice.NV.GOV, and State of Nevada Register of Administrative Regulations. The Workshop notice and the proposed regulation was emailed to individuals on the Board's emailing list.

There were 2 responses received which stated that there was no impact.

Response: On 3/3/2022, a small business impact survey was sent to all licensed Oriental Medicine Doctors and interested persons on the Board's email list to determine the impact of the proposed regulations. The 2 responses received stated that there was no impact.

(F) If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change.

Response: At the Workshop on 4/5/22, the Board went through each new proposed regulation and made the appropriate and necessary changes as suggested by its members and/or the public. If the proposed regulation did not have any suggested changes, then no changes were made.

- (G) The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately, and in each case must include:
  - (1) Both adverse and beneficial effects; and

Response: There is no adverse impact based upon the small business impact survey. The benefits include provisions relating to qualifications of applicants, sections in the state exam, automatic credits of continuing education if they fall within certain categories of NCCAOM approved classes, deletion of prorated fees, elimination of certain Board fees, and acceptance of credit and debit cards, and non-refundability of state exam fees, renewal fees and other matters properly relating thereto.

The immediate and long-term effect is that it will be less costly for the renewal process as the licensees do not have to pay a fee to the Board for CEU course approval; it will be less costly as the new licensees no longer have to pay prorated license fees when they received their license; and it will be less costly as there will no longer be inactive transfer fees.
