LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233B.066

LCB FILE R057-22

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 641A.

1. A clear and concise explanation of the need for the adopted regulation.

The need for the proposed regulations is to protect the public health, safety, and welfare by ensuring that only qualified and competent marriage and family therapists, clinical professional counselors, marriage and family therapist interns and clinical professional counselor interns are licensed in the state.

The purpose of the adopted regulation is to provide clarity for the public, individuals, and licensees through regulations. The proposed regulation adds language that will allow an increase to the maximum allowable supervised experience hours in group therapy and training categories for licensed interns and removes the restriction that no credit be given for supervised practice hours gained prior to becoming an intern in the state of Nevada. The proposed regulation updates continuing education requirements to align with the biennial renewal cycle and adds clarifying language regarding the collection of fees specifically for those affiliated with the military, persons applying for a license through reciprocity and licensees requesting placement on inactive list. The proposed regulation adds clarifying language to supervisory qualifications.

After consideration of all public comments received, the State of Nevada Board of Examiners for Marriage Family Therapists and Clinical Professional Counselors adopted the regulation on **August 19**, **2022**, without change. There were no written comments on the proposed regulation.

The Board determined the regulation was appropriate and necessary and that undue burden is not placed upon licensees as a result of the provisions of the regulation.

There will **be no significant adverse economic effect of these adopted regulations** on the businesses which it is to regulate (marriage and family therapists and clinical professional counselors) nor the public. The adopted regulations will benefit the marriage and family therapists and clinical professional counselors and the public by adding language that will allow an increase to the maximum allowable supervised experience hours in group therapy and training categories for licensed interns and removes the restriction that no credit be given for supervised practice hours gained prior to becoming an intern in the state of Nevada. The adopted regulation updates continuing education requirements to align with the biennial renewal cycle and adds clarifying language regarding the collection of fees specifically for those affiliated with the military, persons applying for a license through reciprocity and licensees requesting placement on inactive list. The adopted regulation adds clarifying language to supervisory qualifications.

(b) Both immediate and long-term effects.

Immediate effect will be improved administration through clarification of existing law and regulatory requirements. Long-term effect will be clarity and consistency in regulation of marriage and family therapists and clinical professional counselors in Nevada.
