January 12, 2023 Legislative Review of Adopted Regulations as Required by NRS 233B.066 LCB File #R133-22

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 388:

1. A clear and concise explanation of the need for the adopted regulation.

The need for the regulation comes from SB485 (2019), which requires the Department of Education to adopt regulations necessary to carry out the requirements associated with the reimbursement of costs for the provision of educational services by a hospital or other facility that provides residential treatment for students from Nevada. Additionally, SB210 (2021) places a number of requirements on public or private schools and the school district in which a child was enrolled when a child is admitted to facility which provides residential treatment for mental illness. It requires the Department of Education to adopt regulations as necessary to carry out the provisions of the requirements placed on that public or private school in the school district.

The proposed amendments to NAC Chapter 388 is to prescribe the required contents of a request for reimbursement of costs incurred by a hospital or other facility for providing educational services to a child to which the hospital or facility provides residential treatment; require such a hospital or other facility to develop a plan for the continued education of the child; and provide for the posting of certain information relating to such plans on an Internet website in accordance with NRS 387.1225 and 432B.60847.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Persons wishing to comment upon the proposed action of the Department of Education were advised of their right to appear at the scheduled public hearing and their right to address comments, data, views or arguments, in written form, to the Board Secretary, Nevada Department of Education 700 E. Fifth St. Suite 100, Carson City, NV 89701. The Department of Education must have received written submissions on or before October 24, 2022. No persons who are directly affected by the proposed action appeared to request time to make an oral presentation; the Department of Education heard and documented the public comment.

The Nevada Department of Education adopted the proposed regulation language at the public hearing held on **October 25, 2022**, with the deletion of subsection 6 of section 7. The regulation submitted in this packet includes the deletion of that language because of concerns shared during public comment.
