Small Business Impact Statement for T006-22

EFFECTIVE DATE OF REGULATION: Upon filing with the Nevada Secretary of State

1. Background:

3. Does the Proposed Regulation Impose a Direct and Significant Economic Burden Upon a Small Business or Directly Restrict the Formation, Operation, or Expansion of a Small Business? (NRS 233B.0608(1)

No, the proposed temporary regulation does not impose a direct and significant economic burden upon a small business or directly restrict the formation, operation or expansion of a small business.

4. How Was That Conclusion Reached?

After attempting to solicit comment from multiple individuals and entities, the Board received no public comment, either oral or written, indicating that this temporary regulation would impose a direct and significant economic burden upon a small business or directly restrict the formation, operation, or expansion of a small business. There was no evidence or information obtained by the Board that would indicate that this temporary regulation is likely to impose a direct and significant economic burden upon a small business or directly restrict the formation, operation, or expansion of a small business. In addition, a review of the text of this temporary regulation indicates that it allows the Board to deny applications for renewal to physicians who have failed to provide application documents that are required by Nevada law. In this temporary regulation, the Board is not creating a new requirement. Instead, it is creating a mechanism to ensure that those physicians who are renewing their licenses must provide required information pursuant to Nevada law before renewing their license. Most physicians

provide these documents when applying for licensure. This just ensures that the Board has a mechanism to get their attention later if/when the physician has failed to provide those documents that are already required by Nevada law.
