Legislative Review of Adopted Regulations as Required by NRS 233B.066
LCB File #R080-24

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 388:

1. A clear and concise explanation of the need for the adopted regulation.

The proposed regulatory language within R080-24 is in response to Governor Lombardo's Executive Order 2023-003, which required all Executive Branch agencies to review their regulations. The proposed language in R080-24 is intended to clean up regulatory language to streamline the work of the State Public Charter School Authority.

This proposed regulatory change previously appeared before the Legislative Commission on December 19, 2024. The SPCSA incorporated feedback from the Legislative Commission into the version of the regulation submitted now.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Public comment was solicited through both the regulation workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop. Notice of Intent to Act Upon a Regulation

Notice of Hearing for the Adoption of Regulations of the State Public Charter School Authority
as proposed in LCB File #R080-24.

The State Public Charter School Authority will hold a public hearing at **9:00AM on Friday, January 23, 2026**, at the **Nevada Legislature Hearing Rooms Building, Room #3 at 7120 Amigo Street, Las Vegas, NV 89119**. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to 388A.010, 388A.250, 388A.255, 388A.260, 388A.400, 388A.410, 388A.415, 388A.650 and 388A.680 of the Nevada Administrative Code (NAC).

The following information is provided pursuant to the requirements of Nevada Revised Statute (NRS) 233B.0603:

1. The need for and the purpose of the proposed regulation or amendment:

Streamline and clarify the processes of the State Public Charter School Authority.

The revised text of the proposed regulation is attached to this notice.

This regulation reorganizes certain provisions relating to the process for the State Public Charter School Authority to approve an application to form a charter school or request to amend a charter contract. Additionally, it revises the terms for which the Authority may renew a charter contract. It repeals authority for the Executive Director of the Authority to develop an abbreviated application to form a charter school and repeals provisions relating to the use of certain gifts, grants, bequests, or donations.

4. Estimated economic effect of the regulation on the business which it is to regulate and on the public:

There is no economic effect of the regulation on the business that it regulates and no impact on the public.

Small business is not impacted by this regulation.
